## Israeli Violations' Activities in the occupied State of Palestine

13 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

## Violations of the Israeli Occupation Army

- The Israeli occupation army (IOA) abducted a young Palestinian man, and detained another, in Hebron, in the southern part of the occupied West Bank. The (IOA) invaded Halhoul town, north of Hebron, and abducted Mousa Ghanem as-Sa'da, 18, before moving him to a nearby military base. The (IOA) also detained a young man, identified as Mo'awiya Abu Haikal, 19, in front of his home in Tal Romeida neighborhood in Hebron city, and took him to a military base in the Old City where he was interrogated for several hours before being released. - The Israeli occupation army (IOA) abducted two Palestinians and injured 46, during protests that erupted at the northern road of the al-Biereh city, in central West Bank, after the army attacked hundreds of residents marking the 17<sup>th</sup> anniversary of the death of late President Yasser Arafat. (IMEMC 12 November 2021)
- The Israeli occupation army (IOA) injured a Palestinian woman in the at-Tiwana village, east of Yatta town, south of the southern West Bank city of Hebron. (IMEMC 12 November 2021)
- The Israeli occupation army (IOA) injured two Palestinians with rubber-coated steel bullets, and caused dozens to suffer the effects of tear gas inhalation, during the weekly procession in Kufur Qaddoum, east of the northern West Bank city of Qalqilia. (IMEMC 12 November 2021)
- The Israeli occupation army (IOA) attacked and injured at least 83 Palestinian protesters during weekly demonstrations against the ongoing illegal Israeli colonization of the occupied West Bank. In Beita town, southeast of Nablus in the northern West Bank, five young men were shot with rubber-coated steel rounds, including an international solidarity activist. Five demonstrators suffered fall related injuries, two from burns, and at least 62 protesters suffered the toxic effects of tear gas inhalation. (IMEMC 12 November 2021)

- The Israeli occupation army (IOA) rounded up the mother of a Palestinian prisoner and two young men in Dosheisha refugee camp in southern Bethlehem. The (IOA) soldiers forced their way into the home of prisoner Akram al-Attairi, who has been in Israeli custody for months, and took away his mother Dareen al-Maghrabi. The two young men were rounded up after breaking into their families' homes and wreaking havoc on them. (Palinfo 12 November 2021)

### **Israeli Settler Violence**

- At least one Palestinian suffered different injuries in a new settlers attack in Hawara town, south of Nablus a group of Jewish settlers assaulted Palestinian olive pickers in the Al-Lahf area, north of Hawara. (Palinfo 12 November 2021)

### **Home Demolition & Demolition threats**

- The Israeli occupation army (IOA) had demolished a number of similar stores in the area since the start of 2021 at the pretext of their proximity to the Beit Hagai Jewish settlement. Beit Hagai has been established on Palestinian lands of Dura town and al-Khalil city since the eighties of the past century. (PALINFO 12 November 2021)

### **Confiscation & Razing of lands**

- The Israeli occupation army (IOA) accompanied by many settlers, uprooted more than 130 trees and bulldozed farmlands in Beit Ummar town, north of Hebron, in the southern part of the occupied West Bank. The (IOA) uprooted more than 130 almond trees, in addition to bulldozing large areas of farmlands near the illegal Karmie Tzur colony, which was built on stolen Palestinian lands. The bulldozed lands and trees are in an area of 5 Dunams, and are owned by the local families of Sa'id Ba'ran and Sabarna. (WAFa 12 November 2021)
- The Israeli occupation army (IOA) razed a Palestinian auto parts store in southern al-Khalil on Thursday. Local sources said that IOF soldiers tore down the 600 square meters store owned by Ahmed Salhab. (PALINFO 12 November 2021)
