

Israeli Violations' Activities in the occupied State of Palestine 17 November 2021

 \mathbf{T} he daily report highlights the violations behind Israeli home demolitions and demolition threats the occupied Palestinian territory, in the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian civilians violence and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

Violations of the Israeli Occupation Army

- The Israeli occupation army (IOA) stormed the village of Bi'lin west of Ramallah in the central occupied West Bank, and arrested four young men, in addition to shooting a number of family members. The army invaded the village before dawn, stormed Palestinian civilian homes and detained four young men identified as Jihad Yassin, Bara'a Burnat, Yamen Burnat, and Yassin Abu Rahma from their homes in the village. During the incursion, the (IOA) opened fire at family members of the young men, injuring at least three family members of Jihad Yassin. The (IOA) shot and injured Abdullah Yassin – (uncle of Jihad), Bassem Yassin – (father of Jihad), and Qamar Al Khatib – (mother of Jihad), before retreating from the village. (IMEMC 17 November 2021)
- The Israeli occupation army (IOA) opened fire at Palestinian-owned farmlands in the central besieged Gaza Strip. The Israeli army opened fire towards farmlands located east of the Al-Bureij refugee camp without causing any casualties. (IMEMC 17 November 2021)
- The Israeli occupation army (IOA) conducted live-fire military drills near the villages of Toura, Taybeh, and Thaher al-'Abed, southwest of the northern West Bank city of Jenin. Dozens of soldiers were deployed in Palestinian olive orchards and farmlands, while several armored vehicles were also roaming in the area during the drills that involved the use of live fire. The Palestinians have been denied access to their farmlands and orchards during the drills, while dozens of soldiers were also deployed near Ya'bad town and all surrounding villages, before closing many roads and areas. (IMEMC 17 November 2021)
- The Israeli occupation army (IOA) detained several Palestinian civilians from their homes in various parts of the occupied West Bank. In the northern part of the West Bank, (IOA)s stormed and ransacked the home of two young men in Jaba' town, south of Jenin before abducting them. (IMEMC 17 November 2021)

- The Israeli occupation army (IOA) dismantled and seized Palestinian structures near az-Za'ayyem village, east of the occupied city of Jerusalem. Director of the village municipality, the (IOA) cordoned al-Saidi herding community, close to the village, where they dismantled two residential structures, each of which occupied 120 square meters, in addition to five sheep shelters, and seized the structures using a crane truck. (IMEMC 17 November 2021)
- Violent clashes erupted in Silwan town in Occupied Jerusalem after Israeli occupation army stormed the area amid heavy firing of teargas and sound bombs. The (IOA) closed Ein Al-Lawza Street in Silwan town, restricting the locals' movement. (Palinfo 17 November 2021)
- Israeli gunboats opened machinegun fire at Palestinian fishing boats off the coast of the besieged Gaza Strip. Gunboats fired some projectiles into the sea near boats off the shore of as-Sudaniya area, northwest of Gaza. Gunboats also opened machinegun fire at other fishing boats off the shores of different coastal areas in Gaza. (PALINFO 17 November 2021)

Israeli Settler Violence

- Settlers, accompanied by Israeli soldiers, attacked today evening staff of the Land Settlement Authority while they were working in Ash-Shuyukh town to the northeast of Hebron, in the southern occupied West Bank, said WAFA correspondent. A group of settlers from the nearby illegal Israeli settlement of Asfar, attacked with stones and clubs staff of the Land Settlement Authority while they were conducting a land survey in the Ash-Shuyukh town, causing one engineer injuries to the head. Israeli soldiers stood idly by and did nothing to stop the settlers. (WAFA 17 November 2021)
- Israeli settlers attacked with stones Palestinian vehicles passing near the entrance of the illegal Israeli settlement of Beit El, northeast of the occupied West Bank city of Ramallah. Eyewitnesses told WAFA dozens of settlers gathered along the road connecting the village of Burqa and Turmusaya town, to the east and north of Ramallah, respectively, and attacked Palestinian-registered vehicles with stones, causing damages to several cars. No injuries were reported. (WAFA 17 November 2021)

• A horde of extremist Jewish settlers attacked Palestinian vehicles traveling on a road near the illegal settlement of Beit El in the northeast of Ramallah. Settlers rallied near the traffic light at the entrance to Beit El and embarked on hurling rocks at passing cars. No one was reportedly hurt, but several cars sustained damage in the attack. (PALINFO 17 November 2021)

Home Demolition & Demolition threats

- The Israeli Municipality of West Jerusalem forced a Palestinian family to demolish its own home in the Ras al-Amoud neighborhood in Silwan of occupied East Jerusalem. It stated that the Burqan family began to demolish their two-storey, 300-square-meter home which they have been building for one year, in order to avoid the unreasonable fines which the municipality would impose if they were to carry out the demolition. The occupation authorities ordered the demolition one month ago, at which time the family attempted to freeze the order but it was denied. According to a family member of the home-owner, Eyad Burqan, the family had to pay 700,000 shekels (\$227,800 US) to rent the demolition equipment. (IMEMC 17 November 2021)
- Israeli authorities notified today of its intentions to demolish two agricultural shacks belonging to Palestinian residents in the village of al-Issawiya in the occupied city of Jerusalem, according to local sources. (WAFA 17 November 2021)
- The Israeli occupation authorities ordered today to stop construction and all forms of work in the Abu Sud neighborhood in the town of al-Khader, south of the occupied West Bank city of Bethlehem, according to activist Ahmed Salah. He told WAFA forces stormed the Abu Sud area and handed a local resident a notice banning construction or making any changes in the area, comprising a surface area of 100 dunums. (WAFA 17 November 2021)
- The Israeli occupation army (IOA) delivered demolition and stop-work orders against 13 homes and structures in western Ramallah. The (IOA) stormed the town and put up notices informing local residents its intents to demolish a number of homes, fences and agricultural wells. Some of the demolitions will be carried out within 96 hours. (PALINFO 17 November 2021)
