Israeli Violations' Activities in the occupied State of Palestine

2 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli Occupation Army

- Israeli occupation Army (IOA) detained at least 13 Palestinians and injured two others across the occupied territories. The (IOA) rounded up two Palestinians after breaking into the houses of their families in the Ramallah city neighborhood of al-Tireh. The (IOA) rounded up two others, including a former prisoner, after ransacking their houses in al-Mazra'a al-Qibliya village, north of Ramallah city. (WAFSA 2 November 2021)

Home Demolition & Demolition threats

- The Israeli occupation army (IOA) notified a Palestinian citizen of its intent to demolish his home in Ya'bad town, southwest of Jenin. Ya'bad mayor Samer Abu Bakr said that Nawwaf Hamdouni received a demolition notice from the (IOA)'s civil administration at the pretext of unlicensed construction. Hamdouni was given until November 11 to file an objection against the demolition order. (PALINFO 2 November 2021)
- The Israeli occupation army (IOA) forced people to demolish, or seized eight Palestinian-owned structures across the West Bank, including East Jerusalem. This resulted in the displacement of two people, and affected the livelihoods or access to services of about 50 others, according to the United Nations Office for the Coordination of Humanitarian Affairs (OCHA) in the occupied Palestinian territory monthly report on West Bank demolitions and displacement for the month of September. All the structures were targeted due to the lack of building permits, which are nearly impossible for Palestinians to obtain in Area C of the West Bank and East Jerusalem. (WAFSA 2 November 2021)
