Israeli Violations' Activities in the occupied State of Palestine

23 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Israeli Settler Violence

- Dozens of Palestinians from Burqa town, north of the northern west bank city of Nablus, intercepted an attack by Israeli settlers against their town, and forced them to leave. The Palestinians noticed the Israeli settlers invading their community, and forced them to leave. The Israeli Occupation Army (IOA) also invaded the village after the settlement stormed it and started firing gas bombs and concussion grenades at the Palestinians. (IMEMC 23 November 2021)
- An attack took place on the Nablus-Jenin Road when the settlers hurled stones at Palestinian cars, in addition to a military invasion into Silet ath-Thaher, south of the northern West Bank city of Jenin, leading to protests; The Israeli Occupation Army (IOA) also fired gas bombs and concussion grenades at the Palestinians. Home Demolition & Demolition threats

- The Israeli occupation authorities (IOA) demolished along with bulldozers invaded the Wadi al-Hummos area of Sur Baher town, southeast of Jerusalem, and demolished a three story home belonging to Ayman al-Heih. (IMEMC 23 November 2021)
- In the southern West Bank, south of Hebron, Israeli occupation Army (IOA) and bulldozers tore down a 200 square meter Palestinian-owned home in the Khirbit Maeen community in Masafer Yatta, under the pretext of building without a license. Two other houses in Khirbit al-Fakhit and Khirbit al-Markaz communities in Masafer Yatta, received demolition orders from the occupation authorities. (IMEMC 23 November 2021)
