 ${f T}$ he daily report highlights the violations behind Israeli home demolitions and demolition threats the occupied Palestinian territory, in the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian civilians violence and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

Violations of the Israeli Occupation Army

- The Israeli Navy opened fire at Palestinian fishermen, while the army opened fire towards agricultural land in different areas of the besieged Gaza Strip. Also the Israeli occupation army (IOA) opened fire towards Palestinian-owned farmland in al-Fakhari town in Khan Younis, in the southern Gaza Strip, with no reported injuries. - Israeli occupation army (IOA) assaulted and dispersed a group of activists taking part in a demonstration outside the archeological Ibrahimi Mosque in Hebron, south of the occupied West Bank, in protest of a plan by Israeli President Isac Herzog to visit the holy site later today to celebrate Hanuka holiday. (WAFA 28 November 2021)

Israeli Settler Violence

• Illegal Israeli settlers harassed Palestinian students in the village of Al-Lubban ash-Sharqiya, south of Nablus in the northern West Bank and Under the full protection of the Israeli military, dozens of settlers added stormed the village, harassing, and chasing the students and their parents, blocking the children from reaching their school. Home Demolition & Demolition threats

• The Israeli occupation army (IOA) in east Jerusalem has notified al-Rajabi family of its intent to demolish their apartment building in Ein al-Luza neighborhood in Silwan district at the pretext of unlicensed construction. (PALINFO 28 November 2021)

Confiscation & Razing of lands

• Israeli bulldozers destroyed water pipes that supplies hundreds of acres of Palestinian-owned lands in the village of Atuf, east of the town of Tammun in the Jordan Valley area, northeast of the occupied West Bank. (WAFA 28 November 2021)
