Israeli Violations' Activities in the occupied State of Palestine

3 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli Occupation Army

- Israeli occupation army (IOA) shot a young Palestinian man, before abducting him near Hebron city, in the southern part of the occupied West Bank. The (IOA) also prevented international diplomats from entering Shuhada Street in Hebron. Media sources said the soldiers invaded an area near the Sammoa' town, south of Hebron, and shot a young man with live fire. Palestinian medics rushed to the area but the soldiers prevented them from reaching the wounded young man and took him to an unknown destination. In addition, the (IOA) prevented more than 30 international diplomats from entering the Shuhada Street area, in the center of Hebron city. (IMEMC 3 NOVEMBER 2021)
- Israeli occupation army (IOA) injured many Palestinians in the eastern area of Nablus city, in the northern part of the occupied West Bank. Media sources said several army jeeps invaded the area to accompany dozens of colonizers into Joseph's Tomb, in the eastern part of the city, leading to protests. The (IOA) also invaded homes and occupied their rooftops, especially in the Amman Street area, to use them as monitoring towers and firing posts. The soldiers fired many live rounds, rubber-coated steel bullets, and gas bombs at the protesters, wounding several Palestinians with the rubber-coated steel bullets and causing many others to suffer the effects of tear gas inhalation. (IMEMC 3 NOVEMBER 2021)
- Many Israeli occupation army (IOA) vehicles invaded several areas in Bethlehem governorate, south of occupied Jerusalem in the West Bank, before the soldiers stormed and searched homes and stores, in addition to inspecting surveillance recordings. Local sources said dozens of (IOA) invaded the villages of Jouret ash-Sham'a, Um Salmouna, Marah Rabah, and al-Manshiyya near Teqoua town, southeast of Bethlehem. They added that the (IOA) broke into and violently searched many shops and homes, and interrogated several Palestinians while inspecting their ID cards. They added that the (IOA) also inspected surveillance recordings in the invaded properties, while the army also surrounded many areas and installed roadblocks. There have been no reports of protests, injuries, or abductions during the invasions. (IMEMC 3 NOVEMBER 2021)

- The Israeli occupation army (IOA) injured a young man and detained another in al-Khalil. (Palinfo 3 November 2021)
- The Israeli occupation army (IOA) abducted a Palestinian father and his son in Yatta town, south of Hebron, in the southern part of the occupied West Bank. (3 NOVEMBER 2021)
- The Israeli occupation army (IOA) injured many Palestinians in the eastern area of Nablus city, in the northern part of the occupied West Bank. The (IOA) abducted a former political prisoner, and detained six farmers from one family, in two separate incidents near Jenin, in northern West Bank. Also on Tuesday evening, the (IOA) shot a young Palestinian man, before abducting him near Hebron city, in the southern part of the occupied West Bank. The army also prevented international diplomats from entering Shuhada Street in Hebron. (IMEMC 3 NOVEMBER 2021)

Israeli Settler Violence

- Israeli settlers assaulted a foreign diplomat and Palestinian olive harvesters in Tuqu' town, southeast of Bethlehem, according to local sources. Mayor of Tuqu', Tayseer Abu-Mefreh, said that South Africa's Counselor-Political, Lesiba Machaba, and the municipality staff joined Palestinian farmers in picking olive groves isolated by the encroaching colonial settlement of Tekoa from the town before they were assaulted by the (IOA).(WAFa 3 November 2021)
- Several Palestinians sustained injuries from the (IOA) gunfire stormed Joseph's Tomb in Nablus city, according. The (IOA) escorted a convoy of buses packed with hundreds of fanatic Jewish settlers into the site, located in the Palestinian-controlled area, sparking confrontations with Palestinian residents. The soldiers opened fire on Palestinians protesting the raid and attempting to block settlers' access to the site, injuring several protestors with rubber-coated steel bullets and causing others to suffocate from tear gas. They occupied the rooftops of several houses in the Amman Street, east of the northern West Bank city, to secure the settler intrusion into the site. Settlers repeatedly break into Joseph's Tomb, located in a densely Palestinian populated area in Nablus, provoking chaos and confrontation with local residents. (WAFa 3 November 2021)

Home Demolition & Demolition threats

- The Israeli occupation army issued demolition orders against five houses in the town of Kafr ad-Dik, west of the occupied West Bank city of Salfit, according to local sources. The (IOA) barged their way into the western part of the town, located on the main road running to the nearby town of Deir Ballut, and handed five residents notices to tear down their houses. (IMEMC 3 NOVEMBER 2021)
- The Israeli occupation army demolished a Palestinian-owned home near Hebron, in the southern part of the occupied West Bank. (IMEMC 3 NOVEMBER 2021)
- The Israeli occupation army (IOA) in east Jerusalem demolished a Palestinian house in Jabel Mukaber district and commercial facilities in Hizma town at the pretext of unlicensed construction. According to local sources, bulldozers escorted by police forces demolished a one-story house in the morning in as-Sal'ah area in Jabel Mukaber belonging to Mohamed Harroub and displaced his family. (PALINFO 3 November 2021)
- The Israeli occupation army (IOA) issued demolition orders against five houses in the town of Kafr ad-Dik, west of the occupied West Bank city of Salfit. The (IOA) barged their way into the western part of the town, located on the main road running to the nearby town of Deir Ballut, and handed five residents notices to tear down their houses. The (IOA) also handed another resident an order to demolish his house in the eastern part of the town, and another an order to halt the construction of his agricultural room. (PALINFO 3 November 2021)
- The Israeli occupation army (IOA) demolished a Palestinian house and stores in the occupied city of Jerusalem, according to local sources. They said that a sizable Israeli police force escorted a bulldozer into al-Sal'a area of al-Mukkaber neighborhood, where the heavy machinery tore down a house belonging to Muhammad Harb, reducing it to rubble. Built 11 years ago, the one-storey two-apartment house was demolished purportedly for being built without a license, displacing Harb's family, which comprises eight members, including three teens under 13 years. (WAFSA 3 November 2021)

Confiscation & Razing of lands

- The Palestinian residents of Jerusalem's Sheikh Jarrah today rejected an Israeli court's ruling delaying their forced expulsion from their houses. Residents of the neighborhood, which became a scene of massive protests against Israel's settler-colonialism in the occupied territories, said in a press statement that they unanimously rejected the "compromise" proposed by the Israeli occupation court under which they shall be "protected tenants", not the owners of their property, while pointing that the "compromise" recognizes the ownership of the settler-colonial group Nahalat Shimon to the land and paves the way for stripping them of their ownership right to their lands. (IMEMC 3 NOVEMBER 2021)
- In the northeast of Jerusalem, a large number of (IOA) stormed an area in Hizma town near a military checkpoint and razed multiple stores belonging to the family of al-Khateeb. The Israeli municipality demolished the stores without informing the family in advance. (PALINFO 3 November 2021)
- Israeli occupation army (IOA) razed a Palestinian house in Aj-Juwaya community, east of Yatta in the southern West Bank district of Hebron. Coordinator of the Protection and Resilience Committees, the (IOA) demolished a 150-square-meter house owned by Ismail Hussein Al-Nawaja, displacing his family, comprising 10 members.
