Israeli Violations' Activities in the occupied State of Palestine

6 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli Occupation Army

- The Israeli occupation army (IOA) attacked Palestinian civilians in Beita town, southeast of Nablus city in the northern part of the West Bank, injuring dozens, including a young man who was shot in the eye. Medical sources have confirmed that the wounded young man, Fayez Hamed Hamayel, lost his right eye, and is receiving treatment at the Najah Hospital in Nablus. In addition, at least five civilians were injured by Israeli forces, in Beita town and nearby Beit Dajan, in addition to 55 cases of teargas inhalation. (IMEMC 6 NOVEMBER 2021)
- The Israeli occupation army (IOA) attacked dozens of Palestinian protesters who were holding a procession in solidarity with the hunger-striking detainees, in Hebron, in the southern part of the occupied West Bank. Media sources said the Palestinians marched at Hebron's northern road while carrying Palestinian flags and pictures of the hunger-striking detainees in Israeli prisons, and chanted for their freedom. They added that the (IOA) attacked the nonviolent protesters with rubber-coated steel bullets, gas bombs, and concussion grenades, causing dozens of injuries. (IMEMC 6 NOVEMBER 2021)
- The Israeli occupation army (IOA) injured a young Palestinian man after the army invaded the al-Bierih city in central occupied West Bank. Eyewitnesses said many army jeeps invaded the city, leading to protests in several neighborhoods before the soldiers fired live rounds, rubber-coated steel bullets, gas bombs, and concussion grenades. They added that a young man was shot with live fire, and dozens suffered the effects of tear gas inhalation, in addition to cuts and bruises. The (IOA) also invaded and ransacked several homes, and occupied the rooftops of a few buildings, in addition to confiscating surveillance recordings. The (IOA) claimed it invaded the city after several shots were fired at a military post in the Psagot colony, illegally built on stolen Palestinian lands on the at-Taweel Mountain. - The Israeli occupation army (IOA) attacked Palestinian olive harvesters in the village of Qaryout, south of the northern West Bank city of Nablus, and forced them to end the harvest and leave their lands, according to witnesses. They said the soldiers held the farmers, seized the equipment they were using in the harvest, and trashed their harvest before forcing

them at gunpoint to stop the harvest and leave their lands. The olive harvest season is one of the major annual events in Palestine and many households depend on the olive harvest for their economic wellbeing. (Wafa 6 November 2021)

- The Israeli occupation army (IOA) poured fortified cement into a Palestinian water spring near Beit Ummar town, north of the southern West Bank city of Hebron. The (IOA) accompanied by trucks invaded the ath-Thaghra area and poured the cement into the spring to permanently close it. The spring was in the ath-Thaghra area, east of Beit Ummar, in lands privately owned by two local Palestinian farmers, identified as Mohammad Abu Ayyash and Bassam 'Aadi. The attack is a serious violation targeting the Palestinians, their lands, and natural resources, and aims at denying the Palestinians access to water unless they buy it from Israeli corporations, illegally operating in the occupied Palestinian territory. Israeli Settler Violence

- A group of Israeli settlers attacked and attempted to destroy a children's playing ground outside the flashpoint village of Susia, to the southwest of Hebron city in the south of the occupied West Bank. Around 200 Israeli settlers attacked the playing ground and attempted to smash some of the fixtures and equipment that were installed by the France-based Action Against Hunger for the area's children. - Three Palestinians sustained fractures and bruises in a fresh attack by hardcore Israeli settlers on the village of Burin, to the south of Nablus in the occupied West Bank. A group of Israeli settlers who apparently came from the nearby illegal Israeli settlement of Yitzhar attacked homes of Palestinians on the outskirts of the village and assaulted local residents, causing fractures to a local Palestinian citizen, who was identified as Adel Eid. Another two Palestinians sustained bruises as a result of the attack. (Wafa 6 November 2021)

Home Demolition & Demolition threats

- The Israeli municipality gave the Palestinian inhabitants of an apartment building in al-Tur neighborhood, east of occupied Jerusalem, one week to demolish the four story building, Quds News Network reported. Ten

Palestinian families, consisting of 70 people, are currently facing the imminent risk of displacement under the orders dictated by the occupation authorities. The Israeli municipality ordered the residents of the building, which was built in 2011, to self demolish the structure within one week, however the families refused, so the occupation army intends to demolish the homes within that time. The municipality threatens to impose heavy fines in addition to demolition charges on the families if it carries out the demolition. The Palestinian families began evacuating their belongings early Friday morning in an effort to avoid losing their possessions when municipality crews come to destroy the building. Confiscation & Razing of lands

- A group of Israeli settlers illegally squatting on stolen Palestinian lands, attacked many Palestinian homes and burnt a small mobile home east of Surif town, north of the southern West Bank city of Hebron. The settlers came from the illegal Beit Ayin colony which was installed on Palestinian lands in khallet Shu'ab al-Qandour area, in Surif. Ghneimat added that the settlers hurled stones at many homes in the area, causing damage, in addition to burning a small mobile home owned by Khalil Abu 'Ahour. Many Palestinians gathered in the area and forced the colonizers to leave. (IMEMC 6 NOVEMBER 2021)
- A group of Jewish settlers cut down 45 olive trees in Burin town, south of Nablus, in the northern occupied West Bank. Ghassan Daghlas, the official in charge of the settlement file in the northern West Bank, affirmed that 45 olive trees were cut down in a settler attack in Burin town near Yitzhar illegal settlement.
