Israeli Violations' Activities in the occupied State of Palestine

8 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli Occupation Army

- Israeli navy ships opened fire at several Palestinian fishing boats in Gaza territorial waters in the northern and southern parts of the besieged coastal region. The navy ships fired several live rounds at the fishing boats, in the allotted fishing zones, in Khan Younis and Rafah, in the southern part of the coastal region. And the attacks did not lead to casualties or damage, but forced the fishermen back to the shore without being able to fish to provide for their families, in fear of further violations and escalation. - The Israeli occupation army (IOA) shot and injured a 12-year-old Palestinian boy in the town of Beit Ummar, north of al-Khalil. Mohammad Awad, who monitors Israeli human rights violations in the area, affirmed that the child was hit with a rubber-coated steel round in the head by Israeli gunfire while he was spending time with his family in their farm near the town. Israeli Settler Violence

- Illegal settlers attacked three Palestinian civilians on their own property, east of Yatta town, south of Hebron city in the southern occupied West Bank, according to a local official. Coordinator of the Protection and Resilience Committees, at least twenty-two settlers attacked three civilians with batons, including two women, in the al-Tha'ala community. (IMEMC 8 NOVEMBER 2021)
- A horde of extremist Jewish settlers attacked Palestinian vehicles traveling on the road between Jenin and Nablus in the occupied West Bank. (PALINFO 8 November 2021)

Israeli Military Orders

- The Israeli occupation army (IOA) delivered stop-work orders against nine Palestinian homes in southern Qalqilya. According to local sources,

Palestinian citizens received military notices ordering them to stop building nine homes in the hamlets of Arab al-Ramadin and Abu Farda, which are located behind the separation wall. The (IOA) justified the measure by claiming that the homes are located in Area C of the West Bank, which is under its control. 70 Palestinians live in the impoverished hamlets of Arab al-Ramadin and Abu Farda, southeast of Qalqilya. (PALINFO 8 November 2021)

- The Israeli occupation army (IOA) ordered stop on the construction of nine homes to the southeast of the West Bank city of Qalqilya. The (IOA) stormed 'Arab ar Ramadin and Arab Abu Farda communities, isolated by the section of Israel's apartheid and annexation wall, where they handed stop-construction orders against nine homes purportedly for being located in Area C.
