## Israeli Violations' Activities in the occupied State of Palestine

9 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

## Violations of the Israeli Occupation Army

- The Israeli occupation army (IOA) abducted four Palestinians, including a mother and her child, in Siolet al-Harithiyya and Ya'bad towns, near the northern West Bank city of Jenin. The (IOA) invaded and ransacked many homes in Siolet al-Harithiyya, west of Jenin, before abducting Sabrin Zayyoud, the wife of a political prisoner, identified as Mohammad Zayyoud who was abducted by the army several months ago, and her child Ziad Mohammad Zayyoud, 14. The (IOA) also abducted Ziad's uncle, a former political prisoner, identified as Maher Zoheir Zayyoud. (IMEMC 9 NOVEMBER 2021)
- The Israeli occupation army injured dozens of Palestinians, including schoolchildren, at the main entrance of the al-'Arroub refugee camp, north of the southern West Bank city of Hebron. Eyewitnesses said several army jeeps invaded the area, especially near the Al-'Arroub Highschool for Boys, and attacked dozens of Palestinians who were holding a nonviolent procession in solidarity with the detainees, and chanting for liberation and independence. The (IOA) fired many gas bombs and concussion grenades, causing scores of residents, including children, to suffer the effects of tear gas inhalation. (IMEMC 9 NOVEMBER 2021)
- The Israeli occupation army (IOA) carried out a small-scale incursion into a border area in the east of the southern Gaza Strip. Five armored bulldozers and two graders escorted by two Merkava tanks advanced from a military post into a border area in the east of Abasan al-Jadida in Khan Yunis. The heavy machinery embarked on leveling and digging swaths of agricultural land, which are located about 70 meters from the border fence. (PALINFO 9 November 2021)

## Home Demolition & Demolition threats

- The Israeli occupation army (IOA) demolished two agricultural rooms and a birds' pen in the Taybeh area in Tarqoumia town, west of Hebron,

in the southern part of the occupied West Bank. (IMEMC 9 NOVEMBER 2021)

- The Israeli occupation army (IOA) demolished three Palestinian homes in the al-Walaja village, west of Bethlehem in the occupied West Bank, allegedly for being built without permits. (IMEMC 9 NOVEMBER 2021)
- Two Palestinian families were forced to self-demolish their homes in different neighborhoods of occupied East Jerusalem. Aziz Oweisa embarked on the destruction of his own home in the Jabal al-Mokabber neighborhood in Jerusalem, under the pretext of building without an Israeli permit. Oweisa was forced to tear down his home due to the occupation army threatening to charge excessive demolition fines, after imposing an unreasonable fine of 32,000 Israeli shekels (\$10,300 US) for building without a license. The Israeli army delivered a demolition order to another Palestinian resident of the Jabal al-Mokabber neighborhood. (IMEMC 9 NOVEMBER 2021)
- Furthermore, in Beit Hanina town, in occupied East Jerusalem, a home was demolished by its Palestinian owner under the pretext of being built without a permit, according to the Wall and settlements Resistance Commission. (IMEMC 9 NOVEMBER 2021)
- The Israeli occupation army (IOA) demolished three inhabited homes and displaced their residents in al-Walaja village, west of Bethlehem, at the pretext of unlicensed construction. The homes are located in Ein Guwaiza area of the village and belong to two brothers and their nephew from the family of Abu-Attin. The (IOA) civil administration had already demolished one of those homes before its owner rebuilt it. (PALINFO 9 November 2021)
- The Israeli occupation army (IOA) forced a Palestinian to demolish his own house in the East Jerusalem neighborhood of Jabal al-Mukaber. Aziz Oweisa tore down his house purportedly for being built without a license after being fined 32,000 shekels (some USD \$10,000) by the occupation authorities. The Oweisa family carried out the demolition to avoid paying exorbitant fines if the Israeli municipality of Jerusalem carries out the demolition on its own. The family received the demolition order two weeks ago, nothing that they were only given until Monday evening to self-demolish the house. (AF 9 November 2021)

- The Israeli occupation army (IOA) demolished three Palestinian houses in al-Walaja village, west of Bethlehem. Deputy mayor of al-Walaja, Khader al-'Araj, said that Israeli forces escorted a bulldozer to the area of Ein Jwaizah, also written as Ein Jweizeh, in the northeastern part of the village, where the heavy machinery tore down a three houses, purportedly for being built without a license. The demolished houses, each of which occupied an area of some 80 square meters, belonged to three members of the Abu al-Tin family, including two brothers. (Wafa 9 November 2021)
- The Israeli occupation army (IOA) demolished a number of structures in al-Taybeh area in the town of Tarqomiya to the west of Hebron, in the southern occupied West Bank. The (IOA) demolished two agricultural sheds and a birdhouse belonging to one of the local residents in the town. (Wafa 9 November 2021)

### **Israeli Military Orders**

- The Israeli occupation army (IOA) delivered stop-work orders against several houses in Masafer Yatta, south of al-Khalil, as a prelude to demolishing them later. A local residents in different areas of Masafer Yatta received stop-work orders against seven homes at the pretext of unlicensed construction. (PALINFO 9 November 2021).

### **Confiscation & Razing of lands**

- The Israeli occupation army (IOA) sprayed toxins into a Palestinian olive orchard in Battir town, west of Bethlehem, south of occupied Jerusalem, in the West Bank, destroying dozens of olive saplings. (MEMC 9 NOVEMBER 2021)
- The Israeli occupation army (IOA) razed a livestock barn in al-Khader town, south of Bethlehem. The (IOA) escorted a bulldozer to al-Suwaneh area in the southwestern section of the town, where the heavy machinery tore down a livestock barn belonging to Mohammad Sbeih, purportedly for being built without a license. (Wafa 10 November 2021)
- The Israeli occupation army (IOA) destroyed dozens of olive trees in the town of Battir, west of the occupied West Bank city of Bethlehem. The (IOA) sprayed chemicals and herbicides to damage recently-planted olive

grove belonging to Ghassan Oweina, east of the town, under the pretext that they were planted in an area classified as “state land”. (WAFA 10 November 2021)
