Israeli Violations' Activities in the occupied State of Palestine

1 December 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli occupation Army

- Israeli soldiers detained, a Palestinian civilian at the Al-Jib military roadblock, northwest of occupied East Jerusalem. The unidentified 43-year-old is resident of Al-Jadira, northwest of Jerusalem. He was detained as he approached the roadblock in his vehicle. Soldiers stopped the vehicle, aimed their weapons at the man and threatened to shoot. (IMEMC 1 December 2021)
- Several Israeli military vehicles invaded, the ar-Ras al-Ahmar Palestinian village, in the Northern Plains of the occupied West Bank, before the soldiers confiscated agricultural equipment in addition to cars, tractors, and water tanks. The soldiers invaded the village before breaking into and ransacking many homes, barns and structures. The soldiers confiscated several cars, tractors, and water tanks owned by the local Palestinian shepherds and farmers. (IMEMC 1 December 2021)
- Israeli soldiers invaded, al-Biereh city in central West Bank, before breaking into and searching several homes, leading to protests. Several army jeeps invaded Jabal at-Tawil neighborhood in the eastern part of the city, before storming residential buildings and homes. The soldiers violently searched the invaded buildings and interrogated many Palestinians while inspecting their ID cards. The invasion led to protests before the soldiers fired several live rounds, gas bombs, and concussion grenades; there have been no reports of injuries. (IMEMC 1 December 2021)

Israeli Settler Violence

- Israeli soldiers shot three Palestinians, and caused dozens more to suffocate on tear gas during a settler invasion into Joseph's Tomb in the northern occupied West Bank city of Nablus. Israeli forces opened fire with tear gas canisters and rubber-coated steel rounds at Palestinians who protested the invasion of hundreds of illegal Israeli colonists into the archeological site known as Joseph's Tomb. Israeli soldiers shot three protesters with rubber-coated steel bullets, including one in the chest. 33

Palestinians suffered the toxic effects of tear gas inhalation. (IMEMC 1 December 2021)

- The Israeli occupation forces (IOF) stormed Ras al-Ahmar hamlet in the northern Jordan Valley and confiscated agricultural equipment and vehicles. A large number of vehicles carrying Israeli troops and workers from the Israeli army's civil administration stormed the hamlet at dawn and embarked on seizing tractors, vehicles and water tanks used for agricultural purposes. Soldiers also broke into and ransacked tents of local residents. (PALINFO 1 December 2021)
- Dozens of Jewish settlers escorted by police forces desecrated the Aqsa Mosque in Occupied Jerusalem. According to local sources, at least 150 settlers entered the Mosque in different groups through its Maghariba Gate and toured its courtyards under tight police protection. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them provocatively performed Talmudic prayers. Meanwhile, the Israeli occupation police imposed movement restrictions on Muslim worshippers, and searched and maltreated many of them in the Old City and on the roads leading to the Aqsa Mosque. House Demolition and Demolition Threats

- Israeli soldiers demolished two agricultural sheds in Nahhalin town, west of Bethlehem, south of occupied Jerusalem, in the West Bank. The Israeli soldiers invaded the an-Nassaba area, in the northern part of the town, before demolishing two agricultural sheds, owned by Majdi Jamil Shakarna and Ala' Mohammad Fannoun. The soldiers claim the two rooms were constructed without permits from the so-called Civil Administration Office, run by the occupation authorities, although the local town council licensed them. The soldiers has recently delivered demolition orders targeting twenty sheds in the an-Nassaba area, Banias, Ra'wanta, Waad Salem, and Qurnat ad-Da'mas, in the town. (IMEMC 1 December 2021)

Israeli Military Orders

- The so-called “Civil Administration Office”, the administrative branch of Israel’s illegal occupation, issued an order for the illegal confiscation of a privately-owned Palestinian land in Beit Jala city, northwest of Bethlehem, south of occupied Jerusalem in the West Bank. The soldiers invaded the land near the western entrance of Beit Jala city and delivered the confiscation order. Israel wants to confiscate the Palestinian lands to expand the “Tunnels Road” leading to Gilo illegal colony which was built on illegally confiscated lands in Beit Jala city and al-Walaja town. Expansion of Settlements

- The Israeli occupation authority (IOA) has approved a new plan to annex vast tracts of agricultural land in the towns of Qaryut and as-Sawiya, south of Nablus, to carry out projects for Jewish settlers. The IOA approved a settlement plan that allows the annexation of Palestinian agricultural lands to use them for the construction of housing units, public facilities and roads for Jewish settlers from the illegal settlement of Eli. The IOA had already announced this plan, but now it approved the appropriation of the area where the settler projects would be built. (PALINFO 1 December 2022)
