## Israeli Violations' Activities in the occupied State of Palestine

12 December 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

## Violations of the Israeli occupation Army

- Israeli soldiers injured several Palestinians in Rummana village, west of the northern West Bank city of Jenin. Many army jeeps invaded the village, leading to protests before the soldiers fired rubber-coated steel bullets, gas bombs, and concussion grenades. Many Palestinians were injured, mainly due to the severe effects of tear gas inhalation, especially after several gas bombs struck homes. (IMEMC 12 December 2021)
- The Israeli soldiers installed a roadblock on the main road in Rommana, especially around UNRWA-schools, before stopping and searching dozens of cars, and interrogated many Palestinians while inspecting their ID cards. (IMEMC 12 December 2021)

## Israeli Settler Violence

- A gang of extremist Jewish settlers on Saturday night wreaked havoc on multiple Palestinian vehicles in Nablus street in Occupied Jerusalem. Jerusalemite lawyer Hamza Qatina said that Jewish settlers destroyed windows of parked cars belonging to him, his brothers and cousins in Nablus streets. Local sources also said that the settlers attacked the Abu Sneineh truck showroom, caused considerable damage to several trucks and tried to set fire to one of them. (PALINFO, NAD 12 December 2021)

## House Demolition and Demolition Threats

- Palestinian families, , were forced by the Israeli authorities to demolish their own homes in the occupied East Jerusalem neighborhood of Silwan,. The Israeli municipality ordered the destruction of three Palestinian-owned apartments in the Wadi Qaddum quarter of Silwan under the pretext of unlicensed construction, leaving three families consisting of twenty members, homeless. The Palestinian Nassar family were forced to **demolish** three apartments in Silwan town to avoid paying excessive fines and demolition fees to the occupation authorities if the Israeli

municipality crews carried out the demolition. Jawad Nassar, his brother and his nephew razed the three apartments which were home to a total of twenty people, with heavy machinery at their own expense, according to Wafa correspondent. (MEMC 12 December 2021)
