

# Israeli Violations' Activities in the occupied State of Palestine 14 December 2021

he daily report highlights the violations behind Israeli home demolitions and demolition threats the occupied Palestinian territory, in the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian civilians violence and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

## Violations of the Israeli occupation Army

- Israeli soldiers shot, a Palestinian child near Ennab military roadblock, east of Tulkarem, in the northern part of the occupied West Bank. The soldiers shot the child, only 14 years of age, with a live round in the thigh. There were no protests in the area but the soldiers fired live rounds at several children who gathered in the area to force them away, wounding the child. (IMEMC 14 December 2021)
- In Ramallah, the central West Bank, the soldiers invaded Bil'in village, west of the city, leading to protests, and fired many gas bombs and concussion grenades, causing several injuries. (IMEMC 14 December 2021)
- Israeli soldiers injured, several Palestinians at the main entrance of the al-'Arroub refugee camp, north of Hebron, in the southern part of the occupied West Bank. The soldiers invaded the area and fired many gas bombs and concussion grenades at the Palestinians to force them away, leading to protests. Several Palestinians suffered the effects of tear gas inhalation, before receiving the needed treatment. (IMEMC 14 December 2021)
- Israeli soldiers uprooted, 120 Palestinian trees on three Dunams of lands, and demolished a well, south of Hebron, in the southern part of the occupied West Bank. several army vehicles including bulldozers, invaded the lands in the Khallet al-Foren area, in Birin village, southeast of Hebron, before uprooting 120 olive and almond trees. The soldiers also demolished a well, used for collecting water from the rain, near bypass road #60, close to the illegal Bnei Hevar colony which was built on stolen Palestinian lands. ## Israeli Settler Violence

• A large number of Jewish settlers escorted by police forces desecrated the Aqsa Mosque in Occupied Jerusalem. Dozens of settlers, including several paramilitary soldiers, entered the Mosque in different groups through its

Maghariba Gate and toured its courtyards under tight police protection, according to local sources. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them provocatively performed Talmudic prayers. Meanwhile, the Israeli occupation police imposed movement restrictions on Muslim worshipers at the Aqsa Mosque's entrances and gates. (PALINFO 14 December 2021)

- A group of Jewish settlers as they tried to infiltrate into a girl school in al-Lubban ash-Sharqiya village, south of Nablus in the occupied West Bank. Dozens of settlers tried to break into the al-Lubban ash-Sharqiya girl school in the village before local residents clashed with them and forced them to leave the area. Meanwhile, about 150 settlers blocked a main road leading to al-Lubban ash-Sharqiya and went on the rampage through nearby areas. No one was reportedly hurt in the settler attacks. (PALINFO 14 December 2021)
- Israeli occupation forces assaulted a number of local farmers in an agricultural area near the village of al-Lubban ash-Sharqiya village, south of Nablus in the occupied West Bank and blocked a nearby road. (PALINFO 14 December 2021)

### House Demolition and Demolition Threats

Israeli soldiers demolished two Palestinian homes, and the foundation of • a third home, in the occupied Palestinian capital, Jerusalem, in the West Bank. Several army jeeps and bulldozers invaded Jabal al-Mokabber town, southeast of Jerusalem, and demolished a home, owned by Ata Ja'fara, allegedly for being built without a permit. Ja'far said that his home, only 90 square/meters, was demolished for the first time in the year 2010 before he rebuilt it to provide shelter for his eleven family members. In addition, the soldiers demolished another Palestinian home, owned by members of the local Husseini family, near Bab al-Magharba, in occupied Jerusalem. The soldiers also demolished the foundations of another home in the Shayyah area, in the at-Tour, in the eastern part of Jerusalem. It is worth mentioning that a month ago, the Burgan family had to demolish its property to avoid the excessively high fines and fees, and today, Tuesday, the soldiers invaded the area and removed the remaining foundations of the property. The owner of the property, the mother of Eyad Burgan, said the family had to demolish its two-story building this past November, to

avoid having to pay more than 400.000 Shekels fines, and added that the army demolished the remaining foundations to force us to pay the expenses and demolition costs. She also said that the demolished property provided shelter to twenty Palestinians, including her four sons and their children. (IMEMC 14 December 2021)

- The Israeli occupation authority (IOA) in east Jerusalem demolished a Palestinian house and the foundations of another one, whose owners were forced to raze last month. A demolition crew escorted by police forces stormed ash-Shayyah area in the east Jerusalem neighborhood of at-Tur, and embarked on knocking down the foundations of a house belonging to the family of Burgan. The family of Burgan had to raze their house about one month ago to avoid paying exorbitant money to the Israeli municipality if they had not complied with its demolition order. The family was surprised to see Israeli machinery demolishing the foundations of the two-story house, which they had demolished in last November to avoid paying 400,000 shekels in fines and demolition expenses. It was not enough for the occupation authorities to demolish Burgan home and displace 20 people, four sons and their kids, the IOA also want to fine the family and make them pay the demolition expenses under flimsy pretexts. - The Israeli occupation authority (IOA) in east Jerusalem demolished in the morning another house belonging to the family of Halis near the Maghariba Gate in east Jerusalem at the pretext of unlicensed construction. (PALINFO 14 December 2021)

### Land Razing and Confiscation

 Israeli occupation authorities (IOA) began razing a Palestinian-owned land at the entrance to Sheikh Jarrah neighborhood in the occupied city of Jerusalem, which was earlier seized under the pretext of "public interest." The IOA municipality crews and bulldozers began the bulldozing work on the confiscated land, an area of about 4,700 square meters owned by four Palestinian families and used as a parking lot and car wash. The Israeli Supreme Court had issued the confiscation order by the end of October with the aim of establishing a park for a nearby Israeli illegal settlement. The Israeli municipality first issued a decision to seize the land in 2016. (PALINFO 14 December 2021)
