# Israeli Violations' Activities in the occupied State of Palestine 16 December 2021

I he daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

The text is not quoted directly from the sources but is edited for clarity.

### Violations of the Israeli occupation Army

- The Israeli occupation forces fired stun and tear gas canisters towards citizens for alleged stoning as they stormed a house during their raid into the village of Minieh. (NAD 16 December 2021)
- The Israeli occupation forces located in front of Al-Aroub camp, fired stun and tear gas canisters towards citizens at the entrance to the camp for alleged stoning. (NAD 16 December 2021)

#### Israeli Settler Violence

• A large number of Jewish settlers escorted by police forces in the morning and later in the afternoon desecrated the Aqsa Mosque in Occupied Jerusalem. At least 125 settlers, including government officials, entered the Mosque in different groups through its Maghariba Gate and toured its courtyards under tight police protection, according to local sources. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them provocatively performed Talmudic prayers. Meanwhile, the Israeli occupation police imposed movement restrictions on Muslim worshipers at the Aqsa Mosque's entrances and gates. (PALINFO 16 December 2021)

#### House Demolition and Demolition Threats

• The Israeli occupation authorities in the Silwan neighborhood of Jerusalem forced the Nassar family to demolish 3 of their homes themselves, after notifying them earlier, in order to avoid paying heavy fines in the event that the Israeli occupation authorities carried out the demolition, on the pretext of not having a permit. (NAD 16 December 2021)

## **Expansion of Settlements**

• The Israeli occupation forces positioned in the Khallet Al-Jara area of the town of Deir Istiya, carried out engineering surveys to build a settlement road in the area. (NAD 16 December 2021)
