

Israeli Violations' Activities in the occupied State of Palestine 28 December 2021

he daily report highlights the violations behind Israeli home demolitions and demolition threats the occupied Palestinian territory, in the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian civilians violence and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

Violations of the Israeli occupation Army

- Israeli forces opened fire, with live rounds, concussion grenades, and tear gas canisters, shooting and injuring six young men with live rounds, one of them seriously, in Tubas, according to local sources. Early in the morning, soldiers stormed the city of Tubas, in the northeastern occupied West Bank which sparked resistance from the local Palestinian youths. Soldiers responded with live fire, shooting six young men, one of them seriously according to the Palestinian Red Crescent Society (PRCS). 6 young men were rushed to hospital for treatment, one of whom was shot in the chest, and deemed in serious condition, and 5 others who were injured in their limbs. - Dozens of Palestinians suffered from teargas inhalation as clashes broke out in Burqa town, northwest of Nablus, between Israeli occupation forces (IOF) and local youths. Clashes broke out between IOF soldiers and local youths who managed to reopen Burqa's entrances which were earlier closed by the IOF. Dozens of people suffered from teargas suffocation. Earlier in time, Israeli troops closed all entrances to the Burqa town and blocked movement in both directions. (PALINFO 28 December 2021)

Israeli Settler Violence

 Hordes of Jewish settlers escorted by police forces desecrated the Aqsa Mosque in Occupied Jerusalem. Scores of settlers entered the Mosque in different groups through its Maghariba Gate and toured its courtyards under tight police protection. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them provocatively performed Talmudic prayers. Meanwhile, several police officers defiled the Aqsa Mosque's Dome of the Rock and al-Marwani prayer buildings and questioned some Muslim worshipers. The Israeli occupation police also imposed movement restrictions on Muslim worshipers at the Aqsa Mosque's entrances and gates. (PALINFO 28 December 2021)

House Demolition and Demolition Threats

- Israeli forces today carried out a large-scale demolition of Palestinian structures in Khirbet Ibziq village, northeast of Tubas. The head of the Khirbat Ibziq village council, Abdel-Majid Khdeirat, told WAFA that a sizable Israeli military force stormed the village in the afternoon hours and declared it a closed military zone, preventing entry and exit from it, before starting large-scale demolitions. He added that as part of the demolitions, Israeli bulldozers razed some 40 structures, including tents and residential and agricultural facilities, belonging to ten families. (IMEMC 28 December 2021)
- Israeli forces demolished, on Tuesday, a Palestinian-owned home in Al-Sindas area, south of Hebron, in the southern occupied West Bank, local sources reported. A large military force accompanied a bulldozer into the area and proceeded to tear down a two-story home with an area of 150 square-meters. The home, which was equiped with a water tank, is located near the settler-only bypass Road #60, and owned by Muhammad Badr al-Atrash, whose family was rendered homeless by the demolition. - Israeli authorities demolished, on Monday, a Palestinian-owned residential building in the al'Isawiya neighborhood in occupied East Jerusalem, under the protection of Israeli police forces. Correspondent for the Palestinian News & Information Agency (WAFA) stated that members of the Municipality of West Jerusalem, under the protection of the occupation police sealed off the area to prevent Palestinian residents from entering. The correspondent added that a bulldozer proceeded to demolish the three-story house, owned by Yasin Mustafa, whose family of 16 people were displaced under the pretext of building without a permit. Local citizens confronted the police during the destruction, but no injuries were reported. (IMEMC 28 December 2021)
- An Israeli court has issued a demolition order against Sur Baher Club in Occupied Jerusalem under the pretext of being built without an Israeliissued permit. The Club's chairman, Ashraf Amera, said that the Israeli occupation authorities (IOA) had earlier issued four demolition notices against the club in less than one year. He underlined that the club

administration had rejected an Israeli offer to take control over the club land in exchange for other projects under Israeli supervision. "Two years ago, we registered the club and its eight-dunum land as an Islamic Waqf (endowment), to protect it from Israeli confiscation attempts," he clarified. The IOA decision is part of the Israeli policy of targeting the Palestinian sports and national identity, he charged. (PALINFO 28 December 2021)
