Israeli Violations' Activities in the occupied State of Palestine

3 December 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli occupation Army

- Israeli forces attacked, two non-violent demonstrations in the northern occupied West Bank, injuring dozens of Palestinian protesters including a journalist. Southeast of Nablus city, in Beita village, soldiers fired live rounds, rubber-coated steel rounds, and tear gas canisters at the demonstrators who gathered to show their rejection of the occupation state's continued settlement expansion. One young man was shot and injured with a live bullet, 28 people, including a journalist, identified as Shadi Jarar'ah, were shot with rubber-coated steel rounds, 11 were burned by tear gas canisters and 147 civilians suffered inhalation injuries. Prior to the rally, bulldozers razed roads leading to Mount Sbeih, in an attempt to block protestors' access to the gathering site, in addition to destroying a water and power line for the community. (IMEMC 3 December 2021)
- In another weekly demonstration held in Beit Dajan village, east of Nablus, Israeli forces opened fire with rubber-coated steel bullets and tear gas canisters, shooting and injuring three young men with steel rounds, and causing 18 demonstrators to suffer the toxic effects of tear gas inhalation. (IMEMC 3 December 2021)
- Israeli forces opened fire, at the weekly non-violent demonstration in Kufur Qaddoum village east of Qalqilia, in the northern occupied West Bank, injuring dozens of Palestinian young men. Israeli troops, hid behind mounds of earth and opened fire with tear gas canisters and rubber-coated steel rounds. Four young men were shot with rubber-coated steel rounds and dozens more suffered the toxic effects of tear gas inhalation. Palestinian demonstrators burned tires to obstruct the soldiers' view and used slingshots to throw tear gas canisters back towards the attacking army. (IMEMC 3 December 2021)

Israeli Settler Violence

- An Israeli settler, while driving his vehicle in Jerusalem, ran over 2 civilians: Imad Muhammad Abu Al-Hawa and Tariq Khweis- both

- residents of the Al-Tur neighborhood in Jerusalem leaving them hospitalized with contusions. (NAD 3 December 2021)
- Groups of Israeli settlers, under the protection of the Israeli occupation police, stormed the courtyards of Al-Aqsa Mosque, and made provocative tours of its courtyards and facilities. (NAD 3 December 2021)
 - A group of Israeli settlers from the outpost of "Ehya" entered the outskirts of Jalud village and attacked the house of Hisham Imad Hammoud. They also damaged the tires of his vehicle, cut down the branches of a number of trees in the vicinity of the house, and stole construction equipment and a generator. (NAD 3 December 2021)

House Demolition and Demolition Threats

- The Israeli occupation forces demolished a shop for building materials in the Jabal Mukaber neighborhood in Jerusalem, under the pretext of not having a license. (NAD 3 December 2021)
- The occupation forces confiscated, at a checkpoint near the entrance to Atouf village, a private vehicle owned by: Fuad Muhammad Suleiman Bisharat - resident of Tamoun town, during his arrest. (NAD 3 December 2021)
- The Israeli occupation forces demolished a retaining wall in the Ain Gwiza area owned by the citizen: Ahmed Ibrahim Al-Araj, and an agricultural room in the Abu Al-Hour area owned by the citizen: Talib Ahmed and Hadna, under the pretext of not having a license in the village of Al Walaja. (NAD 3 December 2021)
- The Israeli occupation forces demolished two residential rooms built of bricks and tin, in addition to demolishing two of the barracks used for raising sheep owned by the citizen: Muhammad Mahmoud Ali Al-Najjar, and two residential rooms, in addition To (Brex) used to raise sheep. It belongs to the citizen: Safaa Abdel-Fattah Al-Najjarin the areas of Al-Fakhit and Al Markaz, located southeast of Yatta. (NAD 3 December 2021)
- The Israeli occupation forces demolished 2 of the "brakes" used for sheep breeding, in addition to demolishing two residential rooms built of bricks and tin owned by the citizen: Muhammad Mahmoud Ali Al-Najjar, and the "brex" used To raise sheep, in addition to two residential rooms owned by the citizen: Safaa Abdel Fattah Al-Najjarin the areas of Al-Fakhit and Al Markaz, located southeast of Yatta.
