Israeli Violations' Activities in the occupied State of Palestine

4 December 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli occupation Army

- Israeli navy ships and soldiers attacked, Palestinian fishing boats and farmers in two separate incidents in the besieged Gaza Strip. The navy fired many live rounds, and used water cannons, in attacking several Palestinian fishing boats less than five nautical miles in Palestinian territorial waters, near Khan Younis, in the southern part of the Gaza Strip. The soldiers also fired sporadic rounds of live fire at farmers, east of Khuza'a town, near Khan Younis, forcing them to leave. The two attacks caused damage, but did not lead to casualties, medical sources in Gaza have confirmed. (IMEMC 4 December 2021)

Israeli Settler Violence

- Israeli colonial settlers let their herd loose on farms owned by Palestinians in Tuba village in Masafer Yatta, south of the occupied West Bank, and then attacked the farmers. Dozens of settlers took their sheep to farming lands in the village and let them loose in the area severely damaging crops. When the farmers attempted to protect their land and get the sheep out, the settlers, who are usually armed, attacked them. Soldiers in the area gave protection to the settlers and arrested one of the Palestinian youths. (IMEMC 4 December 2021)

House Demolition and Demolition Threats

- The Israeli occupation authorities in Jerusalem forced, a Palestinian to demolish his home in Beit Hanina, north of the occupied capital, rendering him and his family homeless only 45 days after the family moved in. The Israeli authorities claim the Palestinian built his home without a permit from the City Council. Standing in front of the rubble of his home, Moath Rajabi said he was handed an official document ordering him to demolish his home or face heavy fines and fees in addition to the demolition costs if the city uses its workers and equipment. Rajabi just moved into his property with his wife and children 45 days ago. He had to

borrow a lot of money to build my home to shelter my family. He received the first order on November 24th, and has since been trying to file appeals, however, he was handed the second order with an ultimatum that also included a threat of even heavier fines and fees. The Palestinian inherited the land from his father and built his fifty-five square/meter home on it, before he was forced to [turn it into rubble](#). (IMEMC 4 December 2021)
