Israeli Violations' Activities in the occupied State of Palestine 5 December 2021

I he daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli occupation Army

- Israeli soldiers invaded the family home of a Palestinian who was shot and killed by Israeli soldiers in occupied Jerusalem, Saturday, and abducted his brother. The soldiers invaded Salfit, in the central West Bank, before storming and ransacking the home of Mohammad Shawkat Salima, 25, and abducted his brother, Ahmad. The soldiers detained and interrogated the entire family for several hours in their home, before abducting Ahmad. The soldiers also fired several gas bombs and concussion grenades around the property, to prevent the residents from reaching it. (IMEMC 5 December 2021)
- In related news, the soldiers invaded Marah Rabah village, south of Bethlehem, and abducted Hamza Khalil Taqatqa, 20, after storming his family's home and ransacking it. The soldiers also abducted a young woman, who remained unidentified at the time of this report, after stopping her in the Bab al-Amoud area, in Jerusalem. (IMEMC 5 December 2021)

Israeli Settler Violence

• Dozens of Jewish settlers escorted by police forces on Sunday morning desecrated the Aqsa Mosque in Occupied Jerusalem. According to local sources, at least 297 settlers entered the Mosque in different groups through its Maghariba Gate and toured its courtyards under tight police protection. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them provocatively performed Talmudic prayers. Meanwhile, the Israeli occupation police imposed movement restrictions on Muslim worshipers, and searched and maltreated many of them in the Old City and on the roads leading to the Aqsa Mosque. House Demolition and Demolition Threats

- The Israeli authorities forced a Palestinian from the Wad al-Hummus area in Sur Baher town, in the occupied capital Jerusalem, to demolish his home, allegedly for being built without a permit. The soldiers forced Mohammad Amira to demolish his 165 square/meter home. Breijiyya added that the Palestinian received the order a few weeks ago and was informed that if he doesn't demolish his property, the City Council would carry the demolition out using its workers and equipment and would force him to pay for the costs in addition to high fines and fees. - Israeli soldiers demolished a car repair facility in Beit Jala city, west of Bethlehem in the occupied West Bank, for the fifth time. Several army jeeps and a bulldozer invaded the city before heading towards the car repair facility and demolishing it. The facility, owned by Hussein Abu Ghalyoon, has been demolished four times before, under the pretext of being built without a permit from the "Civil Administration Office," the administrative branch of the illegal occupation of Palestine. - Israeli soldiers invaded, Beit Furik town, east of the northern West Bank city of Nablus, before confiscating three tents, in addition to forcing the farmer out of his land. The soldiers invaded the as-Suwwana area in Beit Furik after surrounding it. The soldiers confiscated three tents, owned by Arafat Mahmoud Nasasra, and forced him out of his farmland. It is worth mentioning that the soldiers recently invaded the same area and confiscated a tractor owned by Nasasra. (IMEMC 5 December 2021)
- Israeli soldiers invaded Khirbat Ibziq village, in the Northern Plains of the occupied West Bank, and confiscated a Palestinian-owned tractor. The soldiers invaded farmlands in the village and confiscated a tractor, owned by Sami Sa'ad Abu Arra, from Aqaba town. The soldiers forced many Palestinians out of their lands after the army claimed that the area is a "closed military zone." It is worth mentioning that, just a few days ago, the army confiscated more than 20 vehicles, including tractors and bulldozers, in addition to a water tank, from the Khirbat ar-Ras al-Ahmar nearby village. - Israeli soldiers invaded, Khirbat Hamsa Bedouin village, in the Northern Plains of the occupied West Bank, before dismantling and removing three

tents. several army vehicles invaded the village, before the soldiers dismantled three tents, owned by Yasser Abu al-Kabbash, and confiscated them. (IMEMC 5 December 2021)

- Israeli occupation authorities ordered several Palestinian families in the northern Jordan Valley region, in the northeast of the occupied West Bank, to leave their homes for 10 days to make way for Israeli military training in the area. The Israeli occupation army handed notices to several families in the village of Ibzeq, located to the east of Tubas town, ordering them to leave their homes as of today and for 10 days to make way for the training. This means the families will remain outdoors in the extreme winter conditions or aim to find alternative accommodation elsewhere until the end of the Israeli military exercises. - The Israeli occupation authority (IOA) forced a Palestinian citizen to demolish his home in Wadi Humus neighborhood in Sur Baher town, southeast of Jerusalem. Mohamed Omaira had to demolish his own house in Wadi Humus after he recently received a demolition notice from the Israeli municipality. (PALINFO 5 December 2022)
