## Israeli Violations' Activities in the occupied State of Palestine

6 December 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

## Violations of the Israeli occupation Army

- Dozens of Israeli soldiers, and several intelligence officers, invaded and ransacked, a Palestinian home, in occupied Jerusalem, and terrorized the entire family after a family member wrote a Facebook post calling for legally prosecuting the officer who killed a Palestinian last Saturday. The soldiers stormed the home of Jamal Nimir Mahmoud, in the al-'Isawiya town in Jerusalem, after his son, Mahmoud, wrote a post on Facebook calling for the legal prosecution of the soldier who killed Mohammad Shawkat Salima, 25, in Jerusalem, on December 4, 2021. The post prompted an invasion into the family home, and a violent search campaign in the property, leading to excessive property damage, in addition to interrogating the family for several hours. The soldiers also installed many roadblocks in the town, in addition to invading and searching several homes and shops, causing damage. (IMEMC 6 December 2021)

## Israeli Settler Violence

- Dozens of Jewish settlers escorted by police forces desecrated the Aqsa Mosque in Occupied Jerusalem. At least 197 settlers entered the Mosque in different groups through its Maghariba Gate and toured its courtyards under tight police protection. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them provocatively performed Talmudic prayers. Meanwhile, the Israeli occupation police imposed movement restrictions on Muslim worshipers, and searched and maltreated many of them in the Old City streets and at the Aqsa Mosque's entrances and gates. ## House Demolition and Demolition Threats

- A Palestinian family had to demolish its home, in Silwan town, in the occupied capital, Jerusalem, in the West Bank, after the City Council gave them one week to demolish it or be forced to pay high fines and fees in

addition to the demolition costs. The Zeitoun local Palestinian family said it built its home four years ago, before receiving a demolition order, but managed to file an appeal a year ago which led to freezing the order. Adnan Zeitoun, the owner of the property said the family was forced to demolish a section of their home before managing to freeze the demolition order, however, they were slapped with a new order a week ago and had to demolish their property. The new order instructs the family to demolish the property immediately or face the excessively high fines and fees in addition to the demolition costs if the city uses its workers and equipment. It is worth mentioning that a week ago, the Israeli authorities demolished a home, owned by other members of the Zeitoun family. (IMEMC 6 December 2021)

- Israeli forces demolished, two Palestinian-owned homes and a water well south of Hebron, in the southern occupied West Bank. Israeli forces demolished a residential building belonging to Abu Salah al-Ja'abari, in Erfa'ya village, located east of Yatta town. Two civilian homes and a water well were destroyed by Israeli soldiers in the Al-Buwaib and Ziv areas, east of Yatta town. (IMEMC 6 December 2021)
