## Israeli Violations' Activities in the occupied State of Palestine

7 December 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

## Israeli Settler Violence

- Dozens of Jewish settlers desecrated the holy Aqsa Mosque in Occupied Jerusalem under Israeli police protection. Jerusalemite sources said that the settlers broke into the Aqsa Compound in groups and embarked on provocative tours of the holy Islamic site. The groups of settlers, who included students of religious institutes, performed Talmudic rituals at the eastern area of the Compound near the Dome of the Rock. The Israeli occupation police restrict movement of Jerusalemites in in their own city and in the Old City and the Aqsa Mosque's vicinity in particular during the settlers' incursions. ## House Demolition and Demolition Threats

- Israeli soldiers demolished, a Palestinian home and a water well, in addition to bulldozing 105 Dunams of Palestinian-owned lands, in several parts of the southern West Bank governorate of Hebron. Several army jeeps and bulldozers invaded the Abu Khataba area, in the southern part of Hebron city, before demolishing a 60 cubic meters home consisting of three bedrooms, in addition to a kitchen and bathrooms. A local man, Adel Ismael Abu Turki, inhabited the demolished home along with twelve family members. The soldiers also bulldozed the land around the property and demolished several walls. In addition, the soldiers invaded Um al-Kheir village in Masafer Yatta, south of Hebron, and bulldozed 60 Dunams of farmlands owned by a local family. (IMEMC 7 December 2021)
- Israeli soldiers demolished, three agricultural sheds in Nahhalin town, west of Bethlehem, south of the occupied capital, Jerusalem, in the West Bank. Several army jeeps and bulldozers invaded the as-Saleeb and Khallet al-Adas area, in the northern and eastern parts of the town, after surrounding and isolating them. The soldiers demolished three agricultural sheds owned by Mohammad Yousef Awad, Mahmoud Jamil Shakarna, Hamza Rashad Najajra, and Sharif Mosallam Mustafa. During the invasion, the soldiers assaulted many Palestinians, and closed several

areas, in addition to demolishing several retaining walls. (IMEMC 7 December 2021)

- The Israeli occupation authority (IOA) forced a Jerusalemite man to raze his own house in Bir Ayub suburb in Silwan district in Jerusalem at the usual pretext of being built without permit. The house owner Baha'a Zaitun stated that he had to demolish the second story of his house, which has been built four years ago, to evade paying exorbitant money for the IOA municipality crews to do the job. The municipality gave the family one week that ends Tuesday to knock down the second story or else the municipality would raze it and force him to pay the expenses. A demolition verdict against Zaitun house was passed four months ago but he obtained a court order freezing the verdict. However, the municipality issued a new demolition order a week ago, he added. The house provides shelter for six members of the Zaitun family including four children. (PALINFO 7 December 2021)

## Land Razing and Confiscation

- The Israeli soldiers bulldozed 40 Dunams of farmlands in the Zweidein Bedouin community, which is part of the al-Ka'abna Village Council, and Um ad-Daraj in Masafer Yatta. The lands are owned by members of Zweidein and al-Basayta families, near the illegal Karmiel colony which was built on stolen Palestinian lands. The soldiers also bulldozed five dunams of farmlands, owned by the local Shalalda family, in the Sarrara area in the Shiokh town, northeast of Hebron. The lands are close to the illegal Asfar colony, built on stolen Palestinian lands. (IMEMC 7 December 2021)
