



Israeli Violations' Activities in the occupied State of Palestine

26 October 2022

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

Violations of the Israeli Occupation Army

- On Tuesday evening, Israeli soldiers invaded Husan village and the Al-Khader town, west and south of Bethlehem, leading to protests before the army injured several Palestinians in Husan. The soldiers also abducted one Palestinian near Qalqilia, in the northern West Bank. Media sources said several army vehicles invaded the al-Matina area at the eastern entrance of Husan town, leading to protests. They added that the soldiers fired many live rounds, gas bombs, and concussion grenades, causing many Palestinians to suffer the effects of tear gas inhalation. The soldiers also invaded the At-Tal area in the Old City of Al-Khader, leading to protests; the army fired gas bombs and concussion grenades. In Qalqilia, in the northern part of the occupied West Bank, several Israeli army jeeps invaded Hijja village, east of the city, before the soldiers stormed and ransacked a Palestinian home and abducted Younis Jalal Hilan, 19. - On Wednesday dawn, Israeli soldiers invaded the At-Tour and Silwan towns in occupied Jerusalem in the West Bank, leading to protest, before the soldiers abducted one Palestinian after attacking him and his family. Media sources said several army jeeps invaded the at-Tour town and attacked protesters with rubber-coated steel bullets, gas bombs, and concussion grenades. They added that several young men managed to burn a pole with surveillance cameras installed by the police. In Silwan town, the Israeli army and police vehicles invaded the Ein al-Louza and Be'er Ayyoub neighborhoods before stopping and searching dozens of cars, in addition to interrogating many young men, the Wadi Hilweh Information Center In Silwan (Silwanic) has reported. Silwanic added that soldiers randomly fired several gas bombs and concussion grenades, especially in alleys and in front of a few homes. Many Palestinians protested the invasion, and some hurled Molotov cocktails at a security vehicle for illegal colonies in the town and used fireworks to counter the invading army and police vehicles. The soldiers also stormed and ransacked many homes in the town and abducted a young man, Ashraf Buran, after assaulting him and his family. (IMEMC 26 October 2022)

Israeli Settler Violence

- Dozens of Jewish settlers stormed al-Aqsa Mosque under heavy police protection on Wednesday morning. Local sources reported that the settlers entered the Mosque in different groups through its Maghariba Gate, toured its courtyards, and performed Talmudic rituals. The al-Aqsa Mosque is exposed to daily desecration by Jewish settlers and police forces in the morning and the afternoon, except on Fridays and Saturdays. (PALINFO 26 October 2022)
- A horde of Jewish settlers bulldozed on Wednesday swaths of Palestinian-owned land in Wadi al-Faw in the northern Jordan Valley. Mahdi Daraghmeh, head of al-Malih village council, said that settlers embarked on bulldozing swaths of land in Wadi al-Malih area belonging to Palestinian citizens from Tubas City. Local residents and their property in the Jordan Valley are exposed to different violations and crimes, including land grabs, by Jewish settlers on a daily basis. In a separate incident, the Israeli occupation forces blocked on the same day the main entrance of Azzun town in the east of Qalqilya. Local sources said that Israeli bulldozers escorted by soldiers piled up mounds of dirt and rocks at the town's main entrance alongside the road barrier — which has been closed for over two weeks. Home Demolition & Demolition threats

- The Israeli occupation army demolished on Wednesday morning three Palestinian homes in ad-Duyuk at-Tahta village, west of Jericho in the eastern West Bank. According to local sources, bulldozers escorted by Israeli soldiers knocked down three houses, one of them under construction. The demolished homes belonged to three local residents from the village. They were razed at the pretext of unlicensed construction. Israel persists in such demolition policy, although it flagrantly violates the international law. Its systematic demolition of Palestinian homes in the occupied territories is believed to be aimed at psychologically destroying the Palestinian families in an attempt to force them to move from their areas. Other

- A crew from the Israeli education ministry escorted by police forces stormed on Wednesday al-Eman School in Occupied Jerusalem and searched students' bags to look for Palestinian textbooks. According to local sources, a number of parents organized a sit-in outside the Ibrahimia College in the holy city in solidarity with al-Eman School and in protest at the ongoing Israeli targeting of the Palestinian educational sector. The protesters expressed their condemnation of the Israeli raid on al-Eman School in the morning to search for Palestinian curriculum textbooks. A few months ago, Israeli minister of education Yifat Shasha-Biton revoked the licenses of six schools in east Jerusalem, claiming she took such step because of the incitement against Israel and its army in Palestinian school textbooks. At the time, she summoned the principals of those schools for a hearing, and then informed them of her decision to cancel the permanent licenses of their schools and give them conditional licenses for a year as a chance to make changes to their curriculums.
