

Israeli Violations' Activities in the occupied State of Palestine 9 October 2022

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli Occupation Army

- Israeli occupation forces today blocked the main entrance to the town of Anata and the nearby Shu'fat refugee camp, northeast of occupied Jerusalem, denying entry and exit of the local Palestinian residents, according to local sources. Taha Numan, the mayor of Anata, told WAFA that the Israeli occupation army shut down the only entrance to the town last night and raided and searched several homes in the town. He said as a result of the shutdown, schoolchildren were unable to reach their schools, while employees working outside the town were not able to reach their workplaces. Confrontations erupted between the Israeli occupation forces and angry local residents in the aftermath of the Israeli raid and closure of the town's entrance, during which the forces fired teargas canisters and stun grenades at the Palestinian residents. Last night, dozens of Palestinians suffocated from Israeli teargas during an Israeli raid on the town and the neighboring Shu'fat refugee camp. Soldiers also fired rubbercoated rounds and stun grenades at residents during the raid. During the raid, army arrested a Palestinian and his wife and son after their stormed their home. They were identified as members of the Tamimi family. (IMEMC 9 October 2022)
- On Saturday evening, Israeli soldiers invaded Shu'fat refugee camp, north of occupied Jerusalem in the West Bank, leading to protests before the soldiers fired many gas bombs and concussion grenades, wounding many Palestinians; undercover Israeli soldiers also abducted four Palestinians near a military roadblock. Media sources said several army jeeps invaded Shu'fat, leading to protests before the army fired rubber-coated steel bullets, gas bombs, and concussion grenades at the properties and surrounding homes. They added that many Palestinians suffered the effects of tear gas inhalation before receiving the needed treatment. Furthermore, several army jeeps invaded the Dahiat as-Salam area between Shu'fat refugee camp and Anata town, before the soldiers stormed and searched homes and abducted several Palestinians, including a father and his son from the Tamimi family. In related news, undercover officers intercepted a Palestinian car near Anata military roadblock north of Jerusalem and kidnapped four young men before taking them to an

unknown destination. The Israeli soldiers searched many homes in Anata and Shu'fat and interrogated several Palestinians while inspecting their ID cards. The army also closed and isolated the Shu'fat refugee camp after claiming shots were fired at the nearby military roadblock. In Jerusalem city, many army jeeps and police vehicles invaded various areas and streets, including Ras Al-Amoud in Silwan, and installed roadblocks. Furthermore, the army stopped Palestinian Red Crescent ambulances from entering Anata and the Shu'fat refugee camp. (IMEMC 9 October 2022)

A Palestinian young man was injured and several others were kidnaped last night when Israeli police forces stormed Shuafat refugee camp and Anata town in Occupied Jerusalem following the shooting operation that killed a soldier and wounded two others on Saturday evening. According to local sources, a young man suffered a bullet injury in his chest after police forces opened fire at him and other young men during skirmishes with them in the camp. A large number of Israeli forces stormed the camp, raided many homes and interrogated local residents. Several Palestinians were rounded up during the Israeli police raid in the camp. Some of the detainees are relatives of a young man suspected of participating in the Shuafat shooting operation. The Israeli police also laid tight siege to Shuafat camp last night and prevented the local residents from going in or out. The Israeli police claim that at least three Palestinians are involved in the shooting operation. Meanwhile, the entrances of Anata town and as-Salam suburb in east Jerusalem have been closed since last night by the Israeli police. Local sources said that police forces stormed Anata town overnight and kidnaped several citizens from their homes. (PALINFO 9 October 2022)

Israeli Settler Violence

 On Friday night, illegal Israeli colonizers invaded Palestinian agricultural lands in Bardala village, in the Northern Plains of the Jordan Valley, in the occupied West Bank, and uprooted cucumber plants. Mo'taz Bisharat, a Palestinian official who monitors Israel's colonialist activities in the Northern Plains, said the colonizers uprooted large numbers of cucumber plants in greenhouses on more than two Dunams. The colonizers destroyed and uprooted the plants before fleeing the area and heading to a nearby illegal colony. Many areas in the Northern Plains have witnessed a sharp escalation of attacks and violations by the colonizers, especially at night or dawn. The colonizers have also been closing roads and hurling stones at Palestinian cars, and attacking many Palestinians, their homes, tents, sheds, and lands. (IMEMC 9 October 2022)

- A group of Jewish settlers attacked Palestinian vehicles in the northern Jordan Valley, northeast of the West Bank, on Sunday. Local sources reported that Jewish settlers gathered at the crossroad of Ein El Hilweh and blocked the street that connects different areas of the Jordan Valley, imposing restrictions on the movement of Palestinians and attacking their vehicles. In a related development, Jewish settlers from the illegal settlement of Beit El, protected by Israeli occupation forces, hurled stones at the Palestinian vehicles near the northern entrance of the West Bank city of al-Bireh. The Jordan Valley, which constitutes about 25% of the West Bank area, is systematically targeted by the Israeli occupation authorities since its occupation in 1967. (PALINFO 9 October 2022)
- Israeli occupation forces today prevented Palestinian farmers from harvesting their olive crops in the northern West Bank village of Haris, to the central West Bank province of Salfit, according to local sources. Omar Samara, a member of the village's council, told WAFA that an Israeli army force prevented the Palestinian farmers from working in their own land, which is close to the illegal Israeli settlement of Revava, and forced them to leave it. Israeli occupation forces and colonial settlers have intensified their attacks against Palestinian farmers and land in the occupied West Bank, particularly during the annual olive harvest season, destroying trees and preventing farmers at gunpoint from harvesting their crops. The olive harvest season, which has just started, is one of the most important for thousands of Palestinian households in the occupied territories whose income depends heavily on the success of this season. - Dozens of extremist Jewish settlers desecrated the Aqsa Mosque in Occupied Jerusalem under tight police protection on Sunday morning and later in the afternoon. At least 117 settlers entered the Mosque in different groups through its Maghariba Gate and toured its courtyards under police guard, according to al-Qastal News website. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them provocatively performed Talmudic prayers. Meanwhile, the Israeli occupation police imposed movement

restrictions on Muslim worshipers at the Aqsa Mosque's entrances and gates. (PALINFO 9 October 2022)

Home Demolition & Demolition threats

- On Saturday evening, the City Council in occupied Jerusalem, in the West Bank, forced a Palestinian family to demolish its home. Media sources said the family's home is in the Wadi al-Jouz area in Jerusalem, adding that the family has been trying to appeal the demolition order and has already paid heavy fines and fees. The City Council in occupied Jerusalem refused to grant the family of Haj Yahia a permit for their home and threatened to impose much harsher fines in addition to legal prosecution, including imprisonment. The family had to demolish its own home to avoid being forced to pay additional fines and fees and the hefty demolition costs if the city used its workers and equipment. (IMEMC 9 October 2022)
- Israeli occupation forces (IOF) demolished four residential structures in Masafer Yatta, south of the West Bank city of al-Khalil, on Sunday. Local sources reported that the IOF demolished four residential structures belonging to Palestinian citizens southeast of Sussia village in al-Khalil as a prelude to building a settlement road. Meanwhile, the IOF levelled an agricultural land belonging to the Palestinian citizen Khalawi Abu Sneinah in Bireen area northeast of Masafer Yatta, in order to build a 700-meterlong settlement road. Last September, the IOF demolished 71 Palestinian structures and laid their hands on 41 others, according to human rights sources. (PALINFO 9 October 2022)
- Israeli occupation forces today tore down four Palestinian-owned residential structures and razed a plot of land near the town of Yatta, in the southern West Bank province of Hebron, according to local sources.
- Rateb Jabour, a local Palestinian activist, told WAFA that the Israeli occupation army demolished four shacks and razed a plot of land in the village of Susia, near Yatta, under the pretext of construction without a permit. The Israeli occupation army also razed a plot of land in the nearby village of Birin, said Jabour, in order to open a settler-only road in the area. (WAFA 9 October 2022)

Israeli Military Orders

• On Saturday, Israeli soldiers invaded a Palestinian orchard east of Tammoun town, south of Tubas in the northeastern West Bank, and handed a military order for uprooting 140 olive trees. Ghassan Daghlas, a Palestinian official who monitors Israel's illegal colonialist activities in Tubas, said the soldiers invaded olive orchards in Um Kbeish, east of Tammoun. Daghlas added that the soldiers handed a local farmer, Khaled Naji Bani Odah, an order to uproot 140 olive trees in his orchards. The Palestinian planted the olive saplings in his privately owned olive orchard approximately thirteen years earlier. Tubas is one of the Palestinian governorates subject to frequent Israeli violations carried out by the soldiers and the illegal colonizers who frequently invade lands, uproot trees and destroy property.
