Israeli Violations' Activities in the occupied State of Palestine 28 November 2022

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli Occupation Army

- Israeli soldiers killed two Palestinian siblings in Kafr Ein town, northwest of Ramallah, in the central West Bank. The soldiers invaded the town, leading to protests, and fired many live rounds, rubber-coated steel bullets, and gas bombs randomly. The Palestinian Health Ministry has confirmed that the soldiers killed Jawad Abdul-Rahman Rimawi, 22, after shooting him with live fire in the abdomen. The Health Ministry added that the soldiers also shot Jawad's brother, Thafer Rimawi, 21, with a live round in the chest, causing a life-threatening injury, before he succumbed to his serious wounds. Sources at the Yasser Arafat Hospital in Ramallah said the soldiers used expanding bullets against the Palestinians, killing the two siblings and wounding several others, some seriously. On Tuesday dawn, the Palestinian Health Ministry said a Palestinian, Mohammad Mahmoud Ekhlayyel, 44, died from serious wounds he suffered after Israeli soldiers shot and seriously wounded him and injured twenty-one after the army invaded Beit Ummar town, north of Hebron, in the southern part of the occupied West Bank, leading to protests. - Mohammad Masarwa, 25, from Tulkarem, lost sight in his right eye after the Israeli occupation soldiers assaulted him during his arrest at his family's house on January 20 of this year, today said the Prisoners and Ex-Prisoners Affairs Commission. It said in a statement that Israeli soldiers assaulted Masarwa, currently in Israeli custody, with their rifle butts on his head and forehead, which caused a severe injury to the forehead that led to losing vision in his right eye. It said Masarwa was supposed to undergo an operation on his eye this month, but that the Israel Prison Services canceled the operation on the pretext that he is going to finish his sentence in April of next year after serving a year-and-a-half in prison for resisting the occupation. The Commission said Masarwa suffers from severe stomach pains, and that he was given medication for a short period before the prison clinic stopped it without any reason. Masarwa is a former prisoner who spent 20 months in Israeli prisons. (IMEMC 28 November 2022)
- The Israeli occupation forces (IOF) arrested six Palestinian fishermen off Rafah shores, south of the Gaza Strip. The IOF war boats seized two

Palestinian fishing boats while sailing in the Rafah Sea and arrested six fishermen who were aboard. Palestinian fishermen and their boats are frequently targeted by Israeli war boats and have restricted their access to the sea from time to time. (PALINFO 28 November 2022)

Israeli Settler Violence

• Scores of Jewish settlers escorted by police forces desecrated the Aqsa Mosque in Occupied Jerusalem in the morning and later in the afternoon. At least 104 settlers entered the Mosque in groups through its Maghariba Gate and toured its courtyards under police guard. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them provocatively performed Talmudic prayers. Meanwhile, the Israeli occupation police imposed movement and entry restrictions on Muslim worshipers at the Aqsa Mosque's entrances and gates. (PALINFO 28 November 2022)

Home Demolition & Demolition threats

- Israeli soldiers demolished an agricultural shed in the Khallet Al- Forn village in Birin, east of Hebron, in the West Bank's southern part. Rateb Jabour, the coordinator of the Popular Committees against the Annexation Wall and Colonies in Southern Hebron, said the soldiers invaded the village and demolished an agricultural room owned by Gandhi Gheith. Jabour added that the attack is part of ongoing violations by the soldiers and the illegal colonizers, especially since they are trying to expand the Pnei Hever colony, built on stolen Palestinian lands near the village. The families said the army continues to demolish their property and bulldoze their lands and farms, although they have all the deeds providing ownership of their lands. They called on local and international human rights and legal groups to intervene and provide them with the needed protection, especially amidst the constant displacement attempts, demolitions, and escalating assaults by the soldiers and the paramilitary colonizers. - The Israeli occupation forces demolished two Palestinian-owned houses to the east of the occupied West Bank city of Hebron and ordered the demolition of an elementary school in Masafer Yatta, south of Hebron. Israeli forces raided the eastern area of the town and demolished two

houses owned by two local residents. Each house was 120 square meters in area and inhabited by 12 people, who have now become homeless. (IMEMC 28 November 2022)

- Israeli soldiers assaulted and abducted two Palestinian children, and injured one girl, while playing in front of their homes in Hares town, west of Salfit in the central West Bank. The soldiers invaded the town and assaulted Omar Suleiman Daoud, 8, and Thabet Osama Najjar, 7, before abducting him and taking him to a nearby military roadblock. The families have been trying to convince the soldiers to release the children, but they continue to refuse and are trying to move them to a detention facility. (IMEMC 28 November 2022)
- The Israeli soldiers assaulted a girl, Marah Ala' Daoud, 9, causing several injuries, especially to her arms and legs. The soldiers chased and attacked the children in front of their homes at the town's main entrance, wounding Marah before abducting Omar and Thabet. (IMEMC 28 November 2022)
- The Israeli occupation army delivered a demolition notice against the elementary school of Khashm al-Karm in the Bedouin community of al-Badiya in Masafer Yatta, south of Hebron. The army gave the local authorities 96 hours to evacuate the school as a prelude to demolishing it. The school is located within the zoning plan of Arab an-Najada village in Yatta, which has a population of 450 citizens. 33 students from first to fourth grade receive their education at the school, which was established at the beginning of the current academic year with funding from European countries. (PALINFO 28 November 2022)
- The Israeli occupation army demolished two homes in Khallet al-Eidah hamlet near Mount Jawhar in the east of al-Hebron City at the pretext of unlicensed construction. Israeli bulldozers escorted by a large number of Israeli troops stormed Khallet al-Eidah and embarked on knocking down two homes belonging to local residents. The demolition measure rendered families of 12 individuals homeless. The Israeli army also notified local residents in al-Badiya Bedouin community in Masafer Yatta, south of Hebron, of its intent to demolish the elementary school of Khashm al-Karm. (PALINFO 28 November 2022)
- Meanwhile, the Israeli occupation authority in Jerusalem demolished a plant nursery in al-Jib town. The Israeli police also assaulted and detained

- three young men from the town. Two of the detainees are sons of the nursery owner. (PALINFO 28 November 2022)
- The Israeli occupation authorities razed an agricultural room in Khirbet Khallet al-Furun locality, a part of Birin village, east of Hebron. The soldiers escorted a bulldozer to the locality, where the heavy machinery tore down an agricultural room belonging to Ghandi Gheith, who has title deed testifying to his ownership of the plot of land on which the room was constructed. (WAFA 28 November 2022)
- The Israeli military issued a demolition order against a school in Khashem al-Karm community in Masafer Yatta, in the South Hebron Hills. Israeli soldiers raided the area and delivered the demolition order against the school to be carried out within 96 hours. The elementary school contains five classrooms and serves 35 school students from the community and others nearby. (WAFA 28 November 2022)
- The Israeli military demolished a nursery and a stone wall in the town of al-Jeep, northwest of Jerusalem, and detained three youths. Israeli Soldiers broke into an area of the town where a bulldozer demolished a nursery owned by a local resident and in the process detained two of the owner's sons and a third person after assaulting them, which required taking one of the sons to a hospital in West Jerusalem. At the same time, the bulldozer demolished a 60-meter-long stone wall built by another town resident. (WAFA 28 November 2022)
- The Israeli occupation authorities demolished a Palestinian-owned house in Kufr al-Dik town, in the north of the West Bank, that was still in the construction phase under the pretext it was built in Area C of the occupied West Bank. An Israeli army force accompanied by two bulldozers broke into the western part of the town and demolished a two-story, 180-squaremeter house owned by a local resident. Israel claims the house was built without a permit in Area C, which is under full Israeli military rule. (WAFA 28 November 2022)
