

# Israeli Violations' Activities in the occupied State of Palestine 9 February 2023

The daily report highlights the violations behind Israeli home demolitions and threats in the occupied demolition Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, settlers violence the Israeli against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

The text is not quoted directly from the sources but is edited for clarity.

### Violations of the Israeli Occupation Army

- Three Palestinians, who Israeli soldiers shot in Jericho on February 6<sup>th</sup> when the army also killed five Palestinians, remain hospitalized and effectively detained, at Hadassah Israeli medical center in Jerusalem, including one in critical condition. Qussai Farah, 21, from Jericho, was shot in the left side of his abdomen and is currently at the Surgery Ward in stable condition but requires intensive medical care. The second detainee, Hassan Oweidat, 20, at the Intensive Care Unit, suffered multiple gunshot wounds to the shoulder and leg and underwent several surgeries, including implants in his leg, and still requires more surgeries. An Israeli court is planning to hold a hearing to remand him until he recovers before being sent to an interrogation facility. The third wounded detainee, Ala' Awadat from Jericho, remains at the Intensive Care unit in a very serious condition, hooked to a respirator, and added that a court hearing would be held Thursday to remand him. - The Israeli navy arrested two Palestinian fishermen and confiscated their equipment off the northern shores of the Gaza Strip. The Israeli navy arrested two Palestinian fishermen, without providing information about their identity. The Israeli gunboats confiscated a small boat in addition to a paddle and fishing nets that belong to the fishermen. (PALINFO 9 February 2023)
- A Palestinian young man was shot and killed by Israeli occupation forces (IOF) after allegedly attempting to carry out a stabbing attack south of the West Bank city of Hebron. 22-year-old Sharif Rabaa' succumbed to a serious injury inflicted on him by IOF soldiers who claimed that he attempted to stab one of them in Fawwar refugee camp. The IOF shot Rabaa' then took him to an unknown place before declaring him dead. (PALINFO 9 February 2023)
- Israeli occupation forces shot, injured and arrested a Palestinian man near Al-Fawwar refugee camp, in the southern West Bank province of Hebron. The Israeli army force stopped a Palestinian vehicle in the area and opened gunfire at its driver, injuring him with gunshots. The driver, whose medical condition remains unclear so far, was arrested by the attacking soldiers. Meanwhile in Jenin, north of the West Bank, a Palestinian young man sustained injuries after being run over by an Israeli military jeep near Al-

Jalama military checkpoint. An Israeli military jeep chased the young man, who was riding a motorcycle, and deliberately ran over him, injuring him in various parts of the body. (WAFA 9 February 2023)

• A Palestinian youth who was <u>shot and injured</u> by Israeli occupation forces near Al-Fawwar refugee camp, in the southern West Bank province of Hebron, was announced dead of his wounds. The Palestinian youth killed as Sharif Hasan Rabbaa, 22 years old. An Israeli army force stopped a Palestinian vehicle and opened gunfire at its driver, who was later identified as Sharif Hasan Rabbaa, critically injuring him, before arresting him in a bad health condition. # Israeli Settler Violence

• Dozens of Jewish settlers desecrated the Aqsa Mosque in Occupied Jerusalem in the morning and later in the afternoon. At least 131 settlers entered the Mosque in groups through its Maghariba Gate and toured its courtyards under tight police guard. A number of settlers escorted by police officers also gathered in the eastern area of the Mosque and embarked on performing Talmudic prayers. Meanwhile, the Israeli occupation police continued to impose restrictions on the entry of Muslim worshipers to the Mosque, and harassed a number of them during their presence in its courtyards and the entrances leading to it. #### Home Demolition & Demolition threats

- The Israeli occupation army gave the go-ahead for the demolition of three homes belonging to the families of two Palestinian martyrs and one prisoner in the West Bank and Jerusalem. The Israeli army approved measures to demolish the house of prisoner Younis Hailan, near al-Funduq village near Qalqilya, and the homes of martyrs Mohamed Souf and Khairy Alqam, in Hebron. - The Israeli occupation army delivered stop-work orders against several homes in Duma village, south of Nablus, at the pretext of unlicensed construction. Israeli forces stormed the village and handed local residents stop-work orders against eight homes and one farm as a prelude to demolishing them later. Last week, two families of 15 individuals were rendered homeless after the Israeli army's civil administration demolished

their homes in the eastern area of Duma village. (PALINFO 9 February 2023)

Israeli occupation forces notified two Palestinian brothers in the town of Al-Jalama, to the north of Jenin in the northern West Bank, about their intention to demolish their two homes. The Israeli occupation army handed a notification to Jamal and Hesham Abu Farha, the brothers from the town, informing them of a military order to demolish their two homes under the pretext of lacking an Israeli construction permit. The Israeli army also ordered dozens of street vendors near the town to remove their stalls, under the pretext of their proximity to the Israeli military checkpoint of Al-Jalama. The area where Israeli occupation forces ordered the demolition of the two homes in the town is classified as Area C, the more than two-thirds of the occupied West Bank under full Israeli military and civil control. ## Israeli Military Orders

- The Israeli occupation forces (IOF) notified four Palestinian families living in Khirbet Humsa al-Baqi'ah hamlet in the northern Jordan Valley of their intent to carry out military drills near their homes and ordered them to leave the area. 32 individuals, mostly children, were ordered to leave their homes in the hamlet from 8:30 pm to 11:30 pm at the pretext of military exercises, according to local sources. - The Israeli military authorities handed Palestinian households in the village of Duma, south of the northern West Bank city of Nablus, eight stop construction orders against their homes and a ninth against building a farm. The soldiers broke into the village and handed the residents the stop-construction orders that included two two-story and one three-story homes, and a farm. (WAFA 9 February 2023)
