Israeli Violations' Activities in the oPt 1 July 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Brutality of the Israeli Occupation Army

- The Israeli Occupation Army (IOA) raided Dar Salah village east of Bethlehem city and surrounded the house of Yousif Muhammad Ubeidiyah Al Mansi, stormed it using sniffer dogs and thoroughly searched it. Wafa (July 1, 2012).
- One Palestinian (Ibtisam Zeidan, head of Union of Palestinian Women Committees) and a Scottish activist suffered bruises as the Israeli Occupation Army (IOA) suppressed the peaceful demonstration held

in Khallet Al Kotla area near Karmi'el settlement in Beit Ummer town and assaulted demonstrators. Wafa (July 1, 2012)

Israeli Arrests

- The Israeli Occupation Army (IOA) arrested Muhammad 'Ali Saber Abu 'Ayyash (12 years) and Muhammad Ibrahim Saber Abu 'Ayyash (22 years) from Beit Ummer town north of Hebron city. Wafa (July 1, 2012).
- The Israeli reconciliation court extended the arrest of Five Palestinian teens in Al Issawiya town for five more days. The five teens are accused of torching fire near an Israeli military base. Wafa (July 1, 2012)
- The Israeli Occupation Army (IOA) handed two Palestinians from Ad Doha village west of Bethlehem city notifications to interview the Israeli Intelligence Police in Kfar Etzion detention and interrogation center. The delivery of the notification came after the IOA stormed their houses and searched them. The notified Palestinians are identified as 'Adel Malash and Fuad Khaleel Faraj. Wafa (July 1, 2012).
- The Israeli Occupation Authorities (IOA) re-arrested Isma'il Turki 'Okel (18 years), a former prisoner, after summoning him for interrogation in Huwwara detention and interrogation center. It is worth mentioning that citizen 'Okel received a notification from the IOA two days ago to interview the Israeli Intelligence Police. Paltimes (July 1, 2012).
- The Israeli Occupation Army (IOA) arrested three Palestinians east of Al Bureij Refugee camp. The arrestees are: Firas Khaleel Washah (17 years), Salman 'Attiya Al 'Awawdah (20 years) and 'Ali Ghazi Badran (17 years). Paltimes (July 1, 2012).

Israeli Settlers' Violence

- A number of Israeli settlers of Susiya settlement attacked citizens of Kherbit At Tuwani south of Yatta town and threw stones at them. Wafa (July 1, 2012).
- Tens of Israeli settlers raided Joseph Tomb east of Nablus city escorted by the Israeli Occupation Army (IOA). The IOA imposed a closure on the eastern neighborhoods in the city that surround the tomb, Israeli snipers occupied roof tops of some Palestinian buildings that over look the tomb. Settlers practiced religious rituals at the Tomb before withdrawing the area. Clashed erupted between Palestinians and the IOA as a result. Paltimes (July 1, 2012).

Home Demolition & Demolition threats

- The Israeli Municipality of Jerusalem demolished without pre-notification four commercial stores in Bab Al 'Amoud (Damascus Gate) area owned by As Suyuri, As Salayma and Al Jabari families. Wafa (July 1, 2012)
- Israeli Special Forces along with members of the Israeli Municipality of Jerusalem raided Al Bustan neighborhood in Silwan city, stormed a number of houses and photographed them from the inside and outside. The targeted houses are owned by Sbeih Family, Mahmoud Abu Diab, Wael Abu Diab, Musa Odeh, Shihada Qara'ien, Khalaf Huriya and Sa'ed Abu Radi. Clashed erupted between citizens of Al Bustan neighborhood and the Israeli forces as a result of the Israeli raid to the area. Wafa (July 1, 2012).

Erection of Israeli checkpoints

- The Israeli Occupation Authorities (IOA) notified citizens of Wadi Al Khaleel crossing at the entrance of Adh Dhahriyeh town of its intention to confiscate vast areas of lands for the establishment of 3 military observation towers. Paltimes (July 1, 2012).

Others

- The High Court of Justice granted the state's request to postpone the demolition of five houses built on privately owned Palestinian land in the Ulpana neighborhood of Beit El settlement in the West Bank. Last May, the High Court ruled that the houses will be razed by July 1. The justices decided that the demolition will be postponed until mid-November. Last week, the state evacuated the residents of the houses to a nearby temporary base and requested an extension on the date of demolition, in order to dismantle the homes and move them elsewhere.
