## Israeli Violations' Activities in the oPt

09 January 2016

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

## Brutality of the Israeli Occupation Army

- Israeli Occupation gunboats opened fire at Palestinian fishing boats while they were sailing at Al-Waha shore, northwest of Beit Lahiua town and As-Sudanya shore, northwest of Gaza city. (Al-Quds 9 January 2016)
- Israeli Occupation Army (IOA) shoot and killed two Palestinians while they were crossing Al Hamra military checkpoint in the northern of Jordan valley. The martyrs were identified as Ali Abu Maream (26

- years) and Said Abu Al Wafi (38 years). Maannews & Al-Quds 9 January 2016)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Beit Einun junction, northeast of Hebron city. The IOA fired teargas grenades and rubber bullets, causing dozens of suffocation cases and the injury of others. (Al-Quds 9 January 2016)

#### Israeli Arrests

- Israeli Occupation Army (IOA) summoned Mahmoud Hamed Taqatqah and his son Fadi (27 years) to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after raiding their houses in Beit Fajjar village, south of Bethlehem city. (Wafa 9 January 2016)
- Israeli Occupation Army (IOA) summoned Khalil Qassem Ash-Sheik (36 years) to interview the Israeli Intelligence Police in Gush Etzion settlement bloc after storming his house in Marah Rabah village, south of Bethlehem city. (Wafa 9 January 2016)

### Home Demolition & Demolition threats

 Israeli Occupation Army (IOA) demolished a Palestinian house owned by the family of the Palestinian martyr; Muhannad Al Halabi (19 years), in Surda village, north of Ramallah city. Clashes erupted between Palestinians and the IOA, where the IOA fired teargas grenades and metal bullets, causing the injury of three Palestinians. (Maannews 9 January 2016)
