Israeli Violations' Activities in the oPt

15 October 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) stormed and searched a number of Palestinian houses in Deir Samit town in Hebron governorate. One of the targeted houses is owned by Shaher Rayan. (Pal Info 15 October 2015)
- Israeli Occupation Army (IOA) raided and searched dozens of Palestinian houses in Beit 'Awa town, west of Hebron city. (Pal Info 15 October 2015)

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Khursa junction, south of Dura town in Hebron governorate. The IOA fired teargas and stun grenades at Palestinians. (Safa 15 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Bab Az-Zawiya area in the central of Hebron city. (Safa 15 October 2015)
- Two Palestinians were injured and dozens suffered gas inhalation after the Israeli Occupation Army (IOA) stationed near the border fence, east of Al Burij refugee camp in the central of Gaza strip, attacked a non-violent protest. The IOA fired live and rubber bullets, and teargas grenades at Palestinians. (Safa 15 October 2015)
- Israeli Occupation jeeps and bulldozers staged 100 meters into the eastern part of Al Maghazi refugee camp in the central of Gaza strip, and razed land. (Wattan & Safa 15 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Halhil bridge, north of Hebron city. The IOA fired teargas and stun grenades at Palestinians. (RB2000 15 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the southern entrance of Qalqiliyah city. The IOA fired teargas and stun grenades at Palestinians and structures, causing dozens of suffocation cases and the torch of two plastic houses. The targeted structures are owned by Tahseen Shqiro and Daraghma Adwan. (RB2000 15 October 2015)
- Israeli Occupation Army (IOA) stormed and searched a Palestinian house in Yatta town, south of Hebron city, and took photo for it. The targeted house is owned by the family of the Palestinian martyr Amjad Al Jundi. (ARN 15 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) near Beit El settlement, at the northern entrance of Al Bireh city. The IOA fired rubber bullets and teargas grenades, causing dozens of suffocation cases and the injury of two Palestinians. (ARN 15 October 2015)
- A Palestinian was injured and dozens suffered gas inhalation during clashes that erupted between Palestinians and the Israeli Occupation Army (IOA) at the northern entrance of Bethlehem city. The IOA fired live bullets and teargas grenades at Palestinians. (ARN 15 October 2015)
- Riad Ibrahim Dar Yousif (46 years) was killed after the Israeli Occupation Army (IOA) assaulted him after storming his house in Al Janiya village, west of Ramallah city. (NBPRS 15 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in several neighborhoods in Silwan town in Jerusalem city. The

IOA fired teargas and stun grenades at Palestinians, causing dozens of suffocation cases. (SilwanIC 15 October 2015)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Mohamad Imad At-Tarda (15 years) from Taffuh village, west of Hebron city, after the IOA opened fire at him while he was near Adora settlement. The IOA transferred the arrestee to unknown location. (RB2000 15 October 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming and searching their houses in Beit Ula town, northwest of Hebron city. The arrestees were identified as: Mahmoud Abed Al 'afo Mohammad Al 'Amlah (17 years) and Abed Ar-Rahman Fawzi Suliman Al Hadad (21 years). (Wafa 15 October 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians after storming and searching their houses in Beit Ummer town, north of Hebron city. The arrestees were identified as: Hamza Ayman Mohammad Abu 'Ayash (17 years), Amir Imrahim Khalid Sabarnah (22 years) and Malak Fahmi Abed Al Hamed Za'ariq (18 years). (Wafa 15 October 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians after stopping them at Jaba military checkpoint, north of Jerusalem city. The arrestees were identified as: Mohammad Ahmed Nimir Hamdalla Abu Mariya (20 years) from Beit Ummer town, Ra'fat Arafat Al Ja'bari (20 years) and Khalid Abu 'Ayesh from Hebron city. (Wafa 15 October 2015)
- Israeli Occupation Army (IOA) arrested five Palestinians after raiding and searching their houses in Jabal Al Mukabbir town, south of Jerusalem city. The arrestees were identified as: Fadi Nasser, Shadi Nasser, Mutaz Maher, Mohammad Srouf and Adnan Alayan. (Wafa & Wattan 15 October 2015)
- Israeli Occupation Army (IOA) arrested Hassan Suliman Khalilah after storming and searching his house in Jaba village, south of Jenin city. (Wafa & Wattan 15 October 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians after raiding and searching their houses in Tell village, west of Nablus city. The arrestees were identified as: Mohammad Nimir 'Asida (33 years), Jihad Hussen Hindi (23 years) and Mutasem Hassan Yousif Rihan (35 years). (Wafa 15 October 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians from Madama village, south of Nablus city. The arrestees were identified as: Hatheqa Fareda Ziyada and Bashir Hamed Ziyada. (Wafa 15 October 2015)

- Israeli Occupation Army (IOA) arrested three Palestinians and summoned Amer Mustafah Abu 'akir (32 years) and his brother Majdi (28 years) to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after storming and searching their houses in Ayda refugee camp, north of Bethlehem city. The arrestees were identified as: Saleh Ziyad Sarhan (23 years), Khalil Mustafah Abu Akir (22 years) and Mohammad Salah Abu Akir (29 years). (Wafa 15 October 2015)
- Israeli Occupation Army (IOA) summoned three Palestinian girl students from Ash-Sheikh Jarrah neighborhood in Jerusalem city to interview the Israeli Intelligence Police. The Palestinian students were identified as: Maram Mohmmad Daoud, Aya Yousif Yaghmour and Shrouq Maz'rour. (SilwanIC 15 October 2015)
- Israeli Occupation Army (IOA) arrested Ahmed Sanqrout (13 years) and Iyad Omar Ash-Shalabi from Jerusalem city. (SilwanIC 15 October 2015)
- Israeli Occupation Army (IOA) summoned the family of the Palestinian martyr; Ahmed Abu Shaban, to interview the Israeli Intelligence Police, after raiding their house in Silwan town in Jerusalem city. The IOA also, detained for few house Mutaz Amen Jaljal (12 years) (SilwanIC 15 October 2015)

Israeli Settler Violence

- Israeli settlers living in Qiryat Arab settlement escorted by the Israeli Occupation Army (IOA) attacked Palestinian houses in Jabal Jales area in Hebron city. The targeted houses are owned by Ash-Shalhab family. (RB2000 15 October 2015)
- Israeli settlers opened fire at Palestinian children while they were playing at Khursa junction, south of Dura town in Hebron governorate. (RB2000 15 October 2015)
- Israeli settlers living in Efarm settlement escorted by the Israeli Occupation Army (IOA) gathered at Gush Etzion junction and hurled stones at Palestinian vehicles traveled at the Israeli Bypass road No.60. and closed Jerusalem-Hebron road. (ARN 15 October 2015)

Israeli Military Orders

- Israeli court in the Municipality of Jerusalem ordered to evacuate a Palestinian house in the old city of Jerusalem within the next 45 days. The targeted house is owned by Ghaith Sub Laban. (ARN 15 October 2015)
- Israeli Occupation Army (IOA) handed out orders to demolish two Palestinian houses in Silwad town, northeast of Ramallah city. The

targeted houses are owned by the family of the Palestinian prisoner; Abdalla Munir Hamad, and the family of Muaz Hamad. According to the orders the family have to evacuate their houses within 72 hours. Noted that the targeted houses are located in the areas classified as "Area A" according to Oslo Agreement ,1995. (Maannews 15 October 2015)

- Israeli Occupation Authorities handed out orders to demolish the house of a Palestinian prisoner; Abed Mohammad Abu Shaheen, in Qalandiya refugee camp, south of Ramallah city. According to the orders the family have to evacuate their houses within 72 hours. Noted that the targeted house is located in the areas classified as "Area A" according to Oslo Agreement ,1995. (Maannews 15 October 2015)
- Israeli Occupation Authorities issued an order to demolish a Palestinian house in Surda village, north of Ramallah city. The targeted house is owned by the family of the Palestinian martyr; Muhannad Shafeq Al Halabi. Noted that the targeted house is located in the areas classified as "Area A" according to Oslo Agreement ,1995. (Maannews 15 October 2015)
- Israeli Occupation Authorities handed out orders to demolish four Palestinian houses in Nablus city. The targeted houses are owned by families of Palestinian prisoners in the Israeli Jails, identified as: Karam Al Masri, Yahya Hamad, Hakam and Amjad Awad. (NBPRS 15 October 2015)
