Israeli Violations' Activities in the oPt

22 October 2016

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) invaded and searched tens of Palestinian houses in Ash Shawawrah village, east of Bethlehem city. One of the targeted houses is owned by: Ahmed Ad Dar'awi. (Al-Quds & Wattan 22 October 2016)
- Israeli Occupation Navy opened fire at Palestinian fishing boats while they were sailing at As Sudaniya shore, northwest of Gaza strip, causing the injury of two boats. (Sama News & Wattan 22 October 2016)

- Israeli Occupation Army (IOA) opened fire at Palestinian agricultural land located near the border fence, east of Gaza city. (Sama News & Wattan 22 October 2016)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Ziyad Ahmed Husni Zayed after stopping him at Beit Iksa military checkpoint, northwest of Jerusalem city. The IOA transferred the arrestee to unknown location. (Maannews 22 October 2016)
- Israeli Occupation Army (IOA) arrested Jad Ghalib Sultan At Tamimi (38 years) after storming and searching his house in Al Jalda area in Hebron city. The IOA transferred the arrestee to unknown location. (Wafa 22 October 2016)
- Israeli Occupation Army (IOA) summoned Anas Abed Al Jabar Abu Tarboush and Iyad Jihad Nofal Al 'Adawen to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after storming their houses in Al Azza refugee camp, north of Bethlehem city. (Al-Quds 22 October 2016)
- Israeli Occupation Army (IOA) summoned Bassam Abed Ar Rahman Abu 'Akir, Suliman Ar Radi and Nasser Badawnah to interview the Israeli Intelligence Police Gush Etzion settlement bloc, after raiding their houses in Ayda refugee camp, north of Bethlehem city. (Al-Quds 22 October 2016)
- Israeli Occupation Army (IOA) summoned Khalid Mohammad 'Asakrah to interview the Israeli Intelligence Police in Gush Etzion, after storming his house in Al 'Asakrah village, east of Bethlehem city. (Al-Quds 22 October 2016)

Israeli Settler Violence

- Israeli settlers living in Elon Moreh settlement razed vast area of Palestinian land within the village boundary of Deir Al Hatab village, east of Nablus city, and located 2 kilometers away from the settlement (Sama News 21 October 2016)

Erection of Israeli checkpoints

- Israeli Occupation Army (IOA) erected military checkpoints at the northern and southern entrance of Hebron city. The IOA stopped and searched Palestinian vehicles and checked ID cards. (Wafa 22 October 2016)
