## Israeli Violations' Activities in the oPt

4 June 2017

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- Israeli occupation Army (IOA) shot and injured a Palestinian during clashes near the besieged Gaza Strip's border with Israel. Clashes broke out in the southern border area, east of the village of Khuzaa, during which time a Palestinian man was shot with live ammunition in the foot. (Maannews 4 June 2017)
- The Israeli navy forces opened fire at the boats of a number of fishermen who were sailing within the allowed fishing distance forcing them to return to the shore. The Israeli occupation boats deliberately

target fishermen in the Gaza Sea and prevent them from practicing their work by shooting at them, chasing them, and seizing their boats. (PALINFO 4 June 2017)

- Two Palestinians were injured with live ammunition during clashes with Israeli occupation Army (IOA) that erupted in the village of al-Mughayyir, east of Ramallah in the central occupied West Bank. One Palestinian was shot and injured in his right knee, while the other was injured in his left leg. Several other Palestinians suffered from tear gas inhalation as Israeli occupation Army (IOA) raided the village and closed its entrances, fired tear gas canisters, rubber-coated steel bullets, and live fire at residents. (Maannews 4 June 2017)
- Israeli Occupation Army (IOA) stationed at Zaatara checkpoint east of Salfit city launched a surveillance blimp over the checkpoint. The airship, which was supplied with cameras, was launched in the early morning hours and clearly seen in the skies of the towns and villages located between Nablus and Salfit governorates in the West Bank. (Maannews 4 June 2017)
- Two Palestinian young men were injured after the Israeli occupation Army (IOA) attacked Palestinian youths north of Ramallah with teargas canisters. The two Palestinian young men were shot with live ammunition in the clashes that rocked al-Mugheir village, north of Ramallah. Other civilians choked on teargas in the clashes. Shortly before the clashes, heavily-armed Israeli troops stormed al-Mugheir and sealed off the main entrances to the village before they attacked the Palestinian anti-occupation protesters with live bullets and teargas canisters. (PALINFO 4 June 2017)
- Israeli occupation Army (IOA) distributed leaflets to local Palestinians living in Aqbat Hasna and An Nashash areas in Al Khader village west of Bethlehem city threatening locals to harass their daily lives from raids and house searches if “attacks against Israel” continue in the village as claimed in the leaflets. (Wafa 4 June 2017)

## **Israeli Arrests**

- Israeli occupation Army (IOA) raided the village of Husan in the southern occupied West Bank Governorate of Bethlehem, detained one person, and summoned another for interrogation. The IOA raided and searched the home of Kamal Zaoul before detaining his 26-year-old son Waed. During the raid, Israeli soldiers also delivered a summons to appear for questioning at Israel's Etzion detention center south of Bethlehem to Amir Muhammad Sabateen. (Maannews 4 June 2017)

- Israeli occupation Army (IOA) rounded up two Palestinians from al-Ubaidiya village in Bethlehem. The IOA broke into and searched their homes after storming the village. The arrested young men were identified as Qutaiba Khalifa, 18, and Muath al-Asa, 22. (PALINFO 4 June 2017)
- Israeli occupation Army (IOA) arrested the young man Ramez al-Shawish right from his home in Alezeriya town in Occupied Jerusalem. (PALINFO 4 June 2017)
- The Israeli occupation Army (IOA) stormed Silwan town in occupied East Jerusalem and kidnapped three young men from their homes. The detainees were identified as Mohamed al-Abbasi, Ragheb Abu Sanaina, and Ahmed al-Tamimi. (PALINFO 4 June 2017)
- The Israeli occupation Army (IOA) stormed al-Arroub refugee camp in Hebron and kidnapped two Palestinian citizens named Mahmoud Jawabreh and Qusi al-Badawi. (PALINFO 4 June 2017)
- A Palestinian, identified as Mahmoud Ortani, from Jenin, was rounded up at a makeshift checkpoint the Israeli Occupation Army (IOA) set up on a road near Tulkarem city. (PALINFO 4 June 2017)
- In Ramallah, the Israeli Occupation Army (IOA) kidnapped Ahmed al-Sayed and Najmuddin Hamed during a campaign in Beitin town. (PALINFO 4 June 2017)

### **Israeli Settler Violence**

- Israeli settlers opened their gunfire at the family of Yaser Abu Zeid while crossing a bypass road near their home in Deir Estia village in Salfit. (PALINFO 4 June 2017).
- Dozens of Israeli settlers stormed al-Aqsa Mosque via the Maghareba Gate. 90 Israeli settlers, escorted by policemen, broke into al-Aqsa Mosque as part of the four-hour morning break-in shift. Presentations on the counterfeit history of the alleged temple mount were delivered during the break-in. The Israeli settlers also performed sacrilegious rituals near al-Rahma Gate, sparking tension at the site. (PALINFO 4 June 2017).

### **Home Demolition & Demolition threats**

- Israeli Occupation Army (IOA) and bulldozers destroyed eight coal production facilities and confiscated hundreds of tons of wood used for manufacturing charcoal, outside the village of Ya'bad to the west of Jenin in northern West Bank. An Israeli army force accompanied by bulldozers broke into the area and demolished eight coal-production

facilities owned by Jaser Abu Baker and Mohammad Abbadi, two local residents. The IOA also confiscated hundreds of tons of wood used for manufacturing charcoal in these facilities. The IOA and settlers are claiming the coal workshops pollute the environment and cause health problems, but that this is only an excuse to seize the land in favor of expansion of the nearby illegal settlements. This is the second time in less than a month period the Israeli army demolish coal production facilities in Ya'bad. On May 18, army demolished and burnt eight coal-production facilities and two sheds owned by Mahmoud Jaber Abu Baker and Majdi Amarneh in the same area. (Wafa 4 June 2017)

- The Israeli Civil Administration (ICA) escorted by the Israeli occupation Army (IOA) raided Khallet Hamad in the northern Jordan Valley and notified to halt the construction of a solar panel belonging to one Palestinian family in the area. Additionally, the ICA verbally notified to demolish structures in the area under the pretext of unlicensed building. (Wafa 4 June 2017)

### **Confiscation & Razing of lands**

- Israeli military bulldozers staged a limited incursion into Palestinian lands in the southern Gaza Strip, when Israeli soldiers also opened fire at Palestinian farmers in a separate incident near Gaza City. Israeli occupation Army (IOA) opened fire at agricultural lands southeast of Gaza City, forcing Palestinian farmers to leave the area. (Maannews 4 June 2017)
- Four Israeli bulldozers entered tens of meters past the border area into the town of Khuzaa and leveled Palestinian land, while other Israeli military vehicles waited on the Israeli side of the border fence. (Maannews 4 June 2017)
