Israeli Violations' Activities in the occupied State of Palestine

3 September 2020

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli occupation Army

- A Palestinian man suffered a bullet injury, when an Israeli occupation Army (IOA) opened fire at him at the northern entrance to Bethlehem city, in south of the West Bank. Ahmed Abu Akr, 32, from Aida refugee camp, was shot by the IOA who was stationed in a military watchtower near the Bilal bin Rabah Mosque. (IMEMC 3 September 2020)
- The Israeli Occupation Army (IOA) shot and injured a Palestinian man at Zatara military roadblock, south of Nablus city, in the northern West Bank. The IOA stationed at the Zatara military roadblock, opened fire at a vehicle, shooting and moderately injuring a Palestinian man. The IOA denied PRCS medics access to the bleeding man, delaying the necessary medical treatment. The shot Palestinian was identified as Muhammad Jaber Khudair Al-Betawi, from Beita town, south of Nablus. (IMEMC 3 September 2020)
- The Israeli occupation authority (IOA) handed Salah al-Hamouri a written decision revoking his Jerusalemite citizenship documents. Amjad Abu Asab, head of the family committee of Jerusalemite prisoners. The IOA informed Hamouri, a native Jerusalemite citizen, that he would be stripped of his citizenship documents and residency rights, and gave him 30 days to object to the measure. Hamouri spent about eight years in Israeli jails for his peaceful protest activities against the Israeli occupation. He is married to a French woman who was deported by Israel in 2016. (PALINFO 3 September 2020)

Israeli Settler Violence

- At least 123 Jewish settlers stormed the Aqsa Mosque in Occupied Jerusalem and desecrated its courtyards under police escort. 70 students of Jewish religious institutes were among the groups of settlers who entered the Mosque through al-Maghariba Gate and toured its courtyards. Meanwhile, 11 intelligence officers defiled and toured the Aqsa Mosque's main prayer buildings in the morning. (PALINFO 3 September 2020)

Home Demolition & Demolition threats

- The Israeli occupation army (IOA) notified five Palestinian citizens of its intent to demolish their homes and displace their families in Birin village in Masafer Yatta area, south of al-Khalil. The citizens received demolition notices issued by the Israeli army's civil administration against five homes at the pretext that they were built with no permits. The Israeli army has given the families living in these homes 96 hours to evacuate them before its bulldozers come to demolish them. Dozens of women and children will be rendered homeless if the demolitions are carried out. (PALINFO 3 September 2020)
