Israeli Violations' Activities in the occupied State of Palestine

21 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli Occupation Army

- The Israeli Occupation Army (IOA) invaded al-'Isawiya town, in the occupied Palestinian capital, Jerusalem, in the West Bank, before the IOA invaded and ransacked at least one home, and detained three siblings, identified as Bilal, Sultan, and Mohammad Rabah Abu al-Hummus. During the invasion of their home, the IOA assaulted the three siblings along with their fourth brother who was briefly detained. (IMEMC 21 November 2021)
- The Israeli Occupation Army (IOA) repeatedly assaulted a young man, identified as Khader Abu al-Hummus, causing various wounds before he was moved to a hospital. (IMEMC 21 November 2021)
- The Israeli Occupation Army (IOA) injured a Palestinian journalist with a rubber-coated steel bullet and caused many Palestinians to suffer the effects of tear gas inhalation, in addition to detaining a young man, after several army jeeps invaded the central West Bank city of Ramallah and nearby al-Biereh. The IOA invaded the Ein Monjid neighborhood in Ramallah, leading to protests before the IOA fired live rounds, rubber-coated steel bullets, and gas bombs. The IOA shot a journalist, identified as Maher Haroun, with a rubber-coated steel bullet, and caused dozens of residents to suffer the effects of tear gas inhalation. Furthermore, the IOA invaded the al-Biereh city, before storming and ransacking the home of Mohammad Salamin, 28, before detaining him. The IOS also invaded Birzeit city and drove around its various neighborhoods before withdrawing. (IMEMC 21 November 2021)

Israeli Settler Violence

- Israeli settlers attacked many Palestinian cars on the main bypass road, east of Hebron city, in the southern part of the occupied West Bank. A group of settlers gathered in the area and were accompanied by many Israeli soldiers. The settlers hurled stones at their cars, causing damage; no injuries were reported. (IMEMC 21 November 2021)

- A group of Israeli settlers hurled stones at many Palestinian cars near Nablus, in the northern part of the occupied West Bank. The settlers attacked many Palestinian cars on the Nablus-Ramallah Road, causing damage to several vehicles, without leading to injuries. The settlers came from the Yitzhar nearby settlement. Dozens of settlers gathered at the intersection before attacking the Palestinian cars and added that Israeli Occupation Army (IOA) were in the area but failed to intervene and stop them. Home Demolition & Demolition threats

- The Israeli Occupation Army (IOA) demolished two Palestinian structures in the as-Sawahra ash-Sharqiya town, east of the occupied capital, Jerusalem, in the West Bank. The IOA invaded the area earlier and started demolishing two agricultural structures owned by members of Obeidat and Shqairat Palestinian families. During the invasion, personnel of the City Council in occupied Jerusalem handed another Palestinian an order to self-demolish his house in the al-Bustan neighborhood in Jerusalem. The Israeli authorities claim the structures were built without permits from the City Council; such permits are rarely granted to Palestinians, and are very difficult to obtain due to their excessively high cost.
