Israeli Violations' Activities in the occupied State of Palestine

29 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli Occupation Army

- The Israeli occupation army (IOA) invaded the Saff Street, in the center of Bethlehem city, in the occupied West Bank, abducted one Palestinian and injured dozens. Media sources said the soldiers invaded and ransacked the homes on Ismael al-Battat, looking for his son, Ali, but could not find him. (IMEMC 29 November 2021)
- The Israeli occupation army (IOA) abducted a young man from the al-Obeydiyya town, east of Bethlehem, south of occupied Jerusalem, in the West Bank. (IMEMC 29 November 2021)
- The Israeli occupation army (IOA) abducted two young Palestinian men from Qalqilia governorate, in the northern part of the occupied West Bank. (IMEMC 29 November 2021)
- The Israeli occupation army (IOA) abducted three Palestinians from their homes in Anata and Abu Dis towns, near occupied Jerusalem, in the West Bank. (IMEMC 29 November 2021)
- The Israeli occupation army (IOA) ordered a halt on the construction of 22 houses in Qusra village, southeast of Nablus, according to local sources. (Wafa 29 November 2021)
- The Israeli occupation army (IOA) attacked, on Sunday, a non-violent demonstration against the Israeli president's visit to the al-Ibrahimi Mosque in Hebron, in the southern occupied West Bank. Palestinian factions encouraged civilians to gather at the United Nations World Heritage site in protest of the visit by Israeli president, Isac Herzog, for the lighting of the first candle in celebration of the Hannukah holiday, at the Muslim holy site. The IOA were seen brutally attacking the peaceful protesters and snatching Palestinian flags out of their hands. Palestinian officials in addition to Israeli rights groups rejected and criticized the act, calling it a clear provocation against Palestinian muslims, the Palestinian News & Information Agency (Wafa) reported. The army also assaulted protesters at the military roadblocks as they held Palestinian flags and

chanted in rejection of the occupation president's visit. Wafa added that the army closed the gates to the mosque, forced store owners to close shops and obstructed journalists from covering the assault. Herzog lit the first candle at the Muslim holy site while accompanied by illegal settler leaders and members of the Israeli Knesset in an explicit show of cooperation. (IMEMC 29 November 2021)

Home Demolition & Demolition threats

- An Israeli court has given the green light to demolish 58 Palestinian homes and displace their residents in Wadi Yasoul neighborhood in the east Jerusalem district of Silwan at the pretext of unlicensed construction. (PALINFO 29 November 2021)
- The Israeli Occupation bulldozers (IOA) demolished Palestinian-owned water pipes in the northeastern occupied West Bank village of Atuf. The heavy equipment destroyed four kilometers of water line used by farmers to irrigate their crops in Atuf village, east of Tammun town in the Jordan Valley. It is important to note that the occupation authorities frequently demolish and confiscate the essential equipment of Palestinian farmers and civilians in an attempt to force them to leave their rightfully-owned lands. In a serious violation, the army recently poured cement into a Palestinian water spring near Beit Ummar town, north of Hebron in the southern occupied West Bank, permanently closing it. - Israeli soldiers invaded Ni'lin town, northwest of the central West Bank city of Ramallah, demolished a well and injured dozens of Palestinians who protested the violation. The Israeli military bulldozers demolished a well, owned by Fayez al-Khawaja on his own land, under the pretext that it is in a "natural reserve area." The demolished the well just a few days after it was built and was made to hold more than 270 cubic meters of water for irrigation. (IMEMC 29 November 2021)
- The Israeli occupation authorities ordered a halt on the construction of twenty-two houses in Qusra village, southeast of Nablus. The IOA delivered stop-construction orders against twenty-two houses besides to a demolition order against an agricultural shed in the village. (IMEMC 29 November 2021)
