Israeli Violations' Activities in the occupied State of Palestine

30 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

Violations of the Israeli Occupation Army

- The Israeli occupation army (IOA) detained several Palestinian civilians, including former prisoners and a cancer patient from different areas of the occupied West Bank, the Quds Press reported. (IMEMC 30 November 2021)
- The Israeli occupation army (IOA) detained at least 14 Palestinians from various parts of the West Bank. (WAFA 30 November 2021)
- The Israeli occupation army (IOA) detained a Palestinian merchant at Beit Hanoun crossing in the northern Gaza Strip. (WAFA 30 November 2021)
- Several Palestinians sustained injuries from The Israeli occupation army (IOA) gunfire and dozens others suffocated as (IOA) stormed Joseph's Tomb in Nablus city. (WAFA 30 November 2021)
- The Israeli occupation army (IOA) approved today a decision to take over Palestinian-owned land in the villages of Qaruot and al-Sawiyeh to the south of Nablus. (WAFA 30 November 2021)
- Three Palestinians were injured by rubber bullets and many others suffered from their exposure to tear gas during violent The Israeli occupation army (IOA), who stormed the eastern area of Nablus City to provide protection for Jewish settlers. (PALINFO 30 November 2021)

Israeli Settler Violence

- Israeli settlers carried out a provocative rally in al-Wad Street in the Old City of occupied Jerusalem. (WAFA 30 November 2021)

Home Demolition & Demolition threats

- The Israeli occupation army (IOA) demolished a Palestinian-owned home in Silwan town in the occupied city of Jerusalem. The IOA accompanied by bulldozers, surrounded and invaded the Beer Ayoub neighborhood of Silwan town and proceeded to tear down the home under the pretext of having no Israeli permit to build, rendering the family homeless. The owner of the home, Mohammad Zaytoon, a married father of three

children, refused to self-demolish the home he has lived in for five years. In addition soldiers assaulted and obstructed the work of journalists attempting to cover the violations. (IMEMC 30 November 2021)

- In the occupied Jerusalem of town Jabal al-Mokabber, Amir Rabay'a, was forced to demolish his own home after receiving an order from the 'Israeli municipality' to avoid paying demolition fees if the municipality destroys the home. (IMEMC 30 November 2021)
- The Israeli occupation army (IOA) dismantled a Palestinian house in the East Jerusalem neighborhood of Silwan. (Wafa 30 November 2021)
