Israeli Violations' Activities in the occupied State of Palestine

5 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli Occupation Army

- The Palestinian Ministry of Health announced the death of child after he was shot in the abdomen by the Israeli occupation army in Deir al-Hatab village, east of Nablus in the northern occupied West Bank. The (IOA) shot the child, identified as Mohammad Da'das, 13, in the abdomen with live ammunition during confrontations between Palestinian villagers and Israeli soldiers. (IMEMC 5 NOVEMBER 2021)

Israeli Settler Violence

- Israeli army and settlers attacked the weekly anti-settlement procession in Kufur Qaddoum village, in rejection of the illegal colonial schemes by the Israeli occupation, a local official reported. Morad Eshteivi, the media spokesman and coordinator of the popular resistance in the village, stated that during the march, calls rang out from the loudspeakers of local mosques warning villagers that settlers from the nearby Kedumin settlement were attempting to steal the olive harvest from Palestinian farmers. - Israeli settlers attacked Palestinian farmers harvesting their olive crops in the town of Surif, northwest of the occupied West Bank city of Hebron. Hassouna Al-Hih, a group of settlers broke into an outskirt north of the town and attacked Palestinian farmers as they were harvesting their olive crops. At least one light injury was reported. (Wafa 5 November 2021)

Home Demolition & Demolition threats

- The Israeli municipality ordered the demolition of a Palestinian building in Al-Tur town in the occupied city of Jerusalem. The building is housing ten Palestinian families consisting of 70 people including children. The families were given only a few days to evacuate their apartments for the demolition process. The families will self-demolish the building to avoid the heavy expenses imposed by the Israeli municipal authorities. (PALINFO 5 November 2021)
