Israeli Violations' Activities in the occupied State of Palestine

13 December 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli occupation Army

- Several Israeli military vehicles invaded, Palestinian farmlands in the northern part of the Gaza Strip and bulldozed them. The vehicles invaded the lands near the perimeter fence in Beit Hanoun, before bulldozing them, and installed sandhills. During the invasion, military drones flew overhead, and the Palestinians were unable to enter their lands. (IMEMC 13 December 2021)
- Israeli soldiers injured, many Palestinians in Rommana village, west of Jenin, in the northern part of the occupied West Bank. several Israeli army jeeps invaded the town, leading to protests before the soldiers fired many gas bombs, concussion grenades, and rubber-coated steel bullets at the protesters and surrounding homes. many Palestinians, including those in their homes, suffered the effects of tear gas inhalation, and others sustained cuts and bruises. In addition, the soldiers installed a military roadblock on the main road in the town, near UNRWA schools, before stopping and searching dozens of cars and interrogated many Palestinians while inspecting their ID cards. Israeli Settler Violence

- Hordes of Jewish settlers escorted by police forces on Monday morning desecrated the Aqsa Mosque in Occupied Jerusalem. Dozens of settlers, including several paramilitary soldiers, entered the Mosque in different groups through its Maghariba Gate and toured its courtyards under tight police protection, according to local sources. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them provocatively performed Talmudic prayers. Meanwhile, the Israeli occupation police imposed movement restrictions on Muslim worshipers at the Aqsa Mosque's entrances and gates. (PALINFO 13 December 2021)

House Demolition and Demolition Threats

- Israeli soldiers invaded, Nahhalin town, west of Bethlehem, south of occupied Jerusalem in the West Bank, and handed a Palestinian a demolition order targeting his home. Several army jeeps invaded the town before the soldiers handed Atef Jamil al-Nees an order for the demolition of his home. The home, about eighty square/meters, was recently built, and the Palestinian is conducting the final preparations before moving in with his family. The Palestinian was informed that he needs to demolish his home within 96 hours, or else the army would demolish it using its equipment, impose high fines and fees in addition billing him for the demolition costs. The army claims the home was built without a permit from the so-called "Civil Administration Office", the administrative branch of Israel's illegal occupation of the West Bank, although the local town council licensed it. Expansion of Settlements

- The Israeli municipality of West Jerusalem today began work on a plot of Palestinian-owned land at the entrance to Sheikh Jarrah neighborhood in the occupied city of Jerusalem, which was seized under the pretext of "public interest." The municipality crews and bulldozers began the bulldozing work on the land, which has an area of about 4,700 square meters owned by four Palestinian families and was used as a parking lot and carwash. The Israeli Supreme Court allowed at the end of October the takeover of the land by the Israeli municipality with the aim of establishing a garden serving settlers, claiming its close proximity to the so-called Shimon HaTzedik shrine. The municipality issued a decision to seize the land in 2016 after several failed attempts in light of the opposition of the takeover by the four families, who fought the takeover in Israeli courts. Shadi Nassar, one of the tenants of a facility stated that the municipality handed them yesterday an immediate eviction order, otherwise, they will be heavily fined. "We began to dismantle the car wash and a parking lot used by more than 40 buses and three containers that served as offices, and today, since the early morning hours, the municipality began to raze the land," he said. - The Israeli "Custodian General's Unit" of the "Justice Ministry" is planning to build hundreds of units in illegal Israel colonies in occupied

Jerusalem, including in Sheikh Jarrah neighborhood, a move that would lead to the displacement of hundreds of Palestinians from their homes. The plans being promoted would result in extensive constructions in the colonies and “housing projects,” for Jewish settlers in East Jerusalem. The move would include the eviction of hundreds of Palestinians from their homes and neighborhoods. The proposed plans include a new colony in Sheikh Jarrah, and another near Damascus Gate, in addition to one colony in Sur Baher town, and another in Beit Hanina. The Israeli Justice Ministry stated that it is examining plans “for a construction project” in Sheikh Jarrah and denied the existence of other plans. (IMEMC 13 December 2021)
