



## Israeli Violations' Activities in the occupied State of Palestine

27 October 2022

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

## Violations of the Israeli Occupation Army

- Israeli navy ships attacked a Palestinian fishing boat with live fire and gas bombs before abducting the five Palestinian fishermen, including three siblings, and confiscating the boat. The attack took place near the shore of the Sudaniyya Sea area in northern Gaza when the soldiers fired many live rounds and gas bombs at a boat owned by a Morad Al-Hassi. The navy abducted five fishermen, Ahmad Mohammad Al-Hassi, Abdul-Malek Mohammad Al-Hassi, Mohannad Mohammad Al-Hassi, Mahmoud Mohammad Al-Hassi, and Fares Morad Al-Hassi. The soldiers took the abducted fishermen and their boat, which sustained damage in the attack, to Ashdod Port. (IMEMC 27 October 2022)
- Israeli soldiers shot three young Palestinian men, caused dozens to suffer the effects of tear gas inhalation, and abducted eighteen in Beit Ummar and Surif towns, north, and northwest of Hebron. Several army jeeps invaded Beit Ummar before the soldiers stormed, ransacked many homes, and abducted seventeen Palestinians. Many Palestinians protested the invasion before the soldiers shot three young men with rubber-coated steel bullets and caused dozens to suffer the effects of tear gas inhalation. The soldiers interrogated dozens of residents while ransacking their homes in Beit Ummar and abducted seventeen Palestinians, including siblings and several former political prisoners. He said the soldiers abducted Mershed Mohammad Awad, 45, Mahdi Mohammad Mershed Awad, Ashraf Ali Sabarna, 40, Qasem Khaled Al-Allami, 18, Sharif Zohdi Awad, 18, Mohammad Zohdi Awad, 17, Mohammad Rifat Sleibi, 22, Amin Emad Sleibi, Qais Mohammad Abu Mariya, 21, Obai Yousef Abu Mariya, 17, Majd Zoheir Moqbel, 18, Bassam Al-Allami, Jawdat Suleiman Bahar, Ahmad Yousef Alqam, Malek Walid Sabarna, Mohammad Bassem Ekhmayyes, and Bilal Za'aqueq. The soldiers also invaded Surif town, northwest of Hebron, searched homes, and abducted a former political prisoner, Osaid Abu Khdeir. (IMEMC 27 October 2022)
- An Israeli court has sentenced Palestinian soccer player Tareq al-Araj to four years in prison and ordered him to pay a fine of 4,000 shekels (\$1,145). The Israeli occupation forces (IOF) kidnaped Araj, a national youth soccer

- player and a member of the Jenin Sports Club, on September 5, 2020 at a makeshift checkpoint near Jenin City, and then took him for interrogation to the Petah Tikva detention center where he stayed for about one and a half months. The four-year prison sentence was issued against him after his trial was postponed more than 17 times. (Wafa 27 October 2022)
- Israeli occupation forces (IOF) launched a new campaign of raids on several areas of the West Bank, triggering clashes between Palestinian youths and Israeli soldiers. Israeli soldiers blocked the entrance of the Al-Lubban ash-Sharqiya village north of the West Bank city of Nablus during an IOF raid, as part of the siege imposed on Nablus for the 17th day in a row. IOF soldiers fired tear gas bombs at Palestinian protestors who condemned the ongoing siege. (PALINFO 27 October 2022)
  - Israeli soldiers fired tear gas bombs at Palestine Technical University – Kadoorie, west of Tulkarem, which triggered clashes between Palestinian youths and the soldiers. (PALINFO 27 October 2022)
  - Israeli soldiers fired tear gas bombs at Palestinian students as they were leaving schools in Taquu town southeast of the West Bank city of Bethlehem. (PALINFO 27 October 2022)

## Israeli Settler Violence

- Israeli colonizers bulldozed Palestinian lands, harvested olive trees, and stole the produce, in addition to cutting more than 40 olive trees and hurling stones at Palestinian cars in several parts of the occupied West Bank. The colonizers invaded Palestinian farmland and orchards in Salfit and Yasuf town, in the central West Bank, before harvesting Palestinian olive trees and stealing the produce. The colonizers, who came from the illegal Rahalim colony built on Palestinian lands east of Yasuf village, east of Salfit, stole tools used by the Palestinians to pick their olive trees. The tools were on Palestinian olive orchards in the Al-Harayeq area and are owned by Amjad Odah from Salfit city. The colonizers also cut at least forty olive trees in the Wad Abdul-Rahman Valley, north of Salfit, and stole the produce before fleeing the area; the lands are isolated behind the illegal Annexation Wall. While the colonizers can reach the orchards without obstacles, the Palestinians need special permits that are constantly delayed or even denied by the army. The colonizers also hurled stones at many Palestinian cars and trucks in the Wadi Ad-Dalb area and Deir Ibzi' area, west of the central West Bank city of Ramallah. In the Northern Plains of

the West Bank, the colonizers bulldozed Palestinian lands in the Wadi Al-Faw area. Mahdi Daraghma, the head of the Al-Maleh Village Council, said the colonizers bulldozed the lands in the Wadi Al-Faw that belongs to the Wadi Al-Maleh area and added that Palestinians from Tubas city own the lands. - Dozens of Jewish settlers desecrated the Aqsa Mosque in Occupied Jerusalem under tight police protection in the morning and later in the afternoon. At least 101 settlers entered the Mosque in different groups through its Maghariba Gate and toured its courtyards under police guard. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them provocatively performed Talmudic prayers. Meanwhile, the Israeli occupation police imposed movement restrictions on Muslim worshipers at the Aqsa Mosque's entrances and gates. (IMEMC 27 October 2022)

### **Home Demolition & Demolition threats**

- The Israeli occupation army announced its intent to demolish two homes belonging to the families of Palestinian martyrs Ahmed Abed and Abdul-Rahman Abed (cousins) in Kafr Dan town, west of Jenin. The two families were given a deadline to file an objection against the demolition measure. On September 14, the two cousins were shot dead after they killed an Israeli officer during an exchange of fire at a West Bank checkpoint near Jenin. (Wafa 27 October 2022)
- The Israeli occupation authority (IOA) displaced a Jerusalemite family after forcing it to demolish its own home in the Old City. The Israeli municipality forced him to demolish his own house, which is composed of one room, in as-Saadiya neighborhood in the Old City of Jerusalem at the pretext of unlicensed construction. A family of four was living in that small house, which was built about eight years ago. The homeowner added that the IOA forced him to pay about 100,000 shekels in fines for not having a construction license. Hundreds of Jerusalemite homes are threatened with demolition or appropriation as part of Israel's Judaization plans in the occupied holy city. The Jerusalemites have no choice but to build without licenses because there are no structural maps that respond to the natural increase in their numbers. The IOA also imposes building restrictions on the Palestinian natives in Jerusalem and makes it hard for them to obtain construction licenses. Israel's systematic demolition of Palestinian homes in

the holy city is believed to be aimed at psychologically destroying the Jerusalemite families in an attempt to force them to move from their city.
